NOTICE

The DSSSB vide its advertisement No.04/2017 DATED 20/12/2017 had advertised total 131 vacancies (UR-66, OBC-35, SC-18,ST-12 including OH-02,VH-02)) for the post of **PGT(Hindi) Female under Post code-111/17** in Directorate of Education with closing date as 31.01.2018.

- 2. On the basis of online examination of Tier-1 held on 24.07.2018 & 25.07.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of PGT(Hindi), Post Code-111/17 in Directorate of Education, a total of 115 candidates were provisionally nominated vide Result Notice No.376 dated 14.03.2019.
- **3.** Ms. Priya Pandey (**Roll No.110411100687**) under VH category was provisionally nominated vide above said result notice. However, on further scrutiny of the documents uploaded by her, it was noticed that she had not uploaded her PH certificate without which it is not possible to forward her e-dossiers to user department. Therefore, an opportunity was given to her to upload requisite document from <u>13.09.2019</u> to <u>22.09.2019</u> vide supplementary result notice **No.504 dated 09.09.2019**. She was also informed through SMS and e-mail but she failed to upload the requisite document.
- 4. Now therefore, Ms. Priya Pandey (Roll No.110411100687) is being given second and final opportunity to upload her VH certificate in the e dossier module within the stipulated time, i.e. from $\frac{13}{11}\frac{2019}{2019}$ to $\frac{17}{11}\frac{2019}{2019}$ failing which her candidature will be rejected and no further opportunity will be given to her on whatsoever ground.
- 5. The e-dossier module link for above purpose shall be activated from 13/11/2019 to 17/11/2019.
