Subject: - Notice No. 234 to declare Marks/Result for Tier-II Exam and calling of Edossiers for Post code - 14/22 for the Post of Deputy Manager (Accounts) in Delhi Transport Corporation, Govt. of NCT of Delhi.

- The DSSSB vide its advertisement no. 07/22 with closing date 27/08/2022 had advertised 18 vacancies (EWS-01, UR-09, OBC-05, SC-02, ST-01 Including PwD (HH-01, OH-02) for the Post of Deputy Manager (Accounts) in Delhi Transport Corporation, Govt. of NCT of Delhi under post code 14/22.
- 2. The Board has conducted Tier-I Examination (online mode) on 25th June, 2023 and total 27 candidates who obtained marks above or equal to cut-off marks in their respective categories, were provisionally shortlisted to appear in Tier-II examination, vide Result Notice No. 201 dated 22.11.2023, subject to the information furnished by the candidates in their online application forms.
- The Board has conducted Tier-II examination (online mode) on 02.03.2024 and total 24 candidates appeared in said exam, out of 27 shortlisted candidates.
- 4. Marks obtained by 24 candidates who have duly appeared in Tier-II written online examination held on 02.03.2024 have been uploaded on Board's website. Candidate can view their marks by logging in to their account in OARS module on www.dsssbonline.nic.in.
- 5. Based on the performance in the Tier-II examination (online Mode), total 24 candidates who have secured equal and more marks in their respective category as per the detail given below are provisionally shortlisted and accordingly, allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form: -

- 6. The short listed candidates for the above mentioned post code are hereby directed to logon to the e-dossier module and upload all the documents of education certificate(s)/Professional/Experience certificates/Degree and mark sheets/caste certificate/Admit cards/proof of Govt. servant/Ex Serviceman etc., as applicable, in the e-dossier module in their individual accounts in OARS module. Short listing is being made on the basis of marks obtained in Tier-II examination.
- Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 5 above.

- 8. All the candidates who have been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.
- The e-dossier link shall be active from <u>06.08.2024</u> to <u>20.08.2024</u>. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 27/08/2022.
- 10. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID <u>as an additional facility</u>. If any candidate fails to upload the e-dossier during above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 11. All the candidates who have been shortlisted for uploading e-dossiers **MUST** upload their all requisite/applicable documents in the said link in stipulated time i.e., 06.08.2024 to 20.08.2024.
- 12. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above, he/she will not be given any further opportunity and his candidature will be treated as cancelled.
- 13. The above short listing of candidates for calling of e-dossier for the post code 14/22 will be subject to outcome of pending court cases, if any.
- 14. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
