Further, it may also be verified that the candidate does not belong to the person/section (Creamy Layer) mentioned in cloumn 3 of the schedule to the Govt. Of Inida, Department of Personal and Training O.M No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M No. 36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M No. 36033/3/2004-Estt.(Res) dated 14.10.2008.

The selection of the above (36) candidates shall further be subject to candidate's fulfilling the eligibility conditions of the post, as prescribed by the statutory Recruitment Rules and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of their identity with reference to their photograph, signatures and handwriting etc., on the application form, admission certificates etc. The candidature of the candidate is liable to be cancelled by the user Department also, in case candidate is found not fulfilling the eligibility conditions or any other genuine reason.
