On scrutiny of the documents in the e-dossier, it has been noticed that the some of the candidates have uploaded their e-dossier with deficient documents and accordingly, their candidature had been kept pending for want of deficient / requisite documents in the e-dossier and accordingly, 04 candidates are being given 1st opportunity w.e.f. 02/12/2021 to 11/12/2021 to upload the deficient /requisite documents as mentioned against their Roll Nos.:-

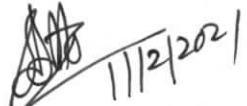

1	111602400290	The candidate has not uploaded B.Ed. degree and its marks sheet. In case, the candidate has not done B.Ed., than a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). The candidate is directed to upload the above documents in the single PDF file in the e-dossier whichever link is open for uploading of deficient documents in the e-dossier.
2	121102400098	The candidate has not done B.Ed. degree & its marks sheet. However, undertaking for B.Ed. given but she has second division in M.Com. Hence, undertaking is applicable only in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination. Therefore, the candidate is directed to upload B.Ed. degree as on cutoff date, failing which her candidature will be rejected.
3	111602400004	The candidate has not uploaded B.Ed. degree and its marks sheet. In case, the candidate has not done B.Ed., than a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). The candidate is directed to upload the above documents in the single PDF file in the e-dossier whichever link is open for uploading of deficient documents in the e-dossier.
4	111602400244	Physically disabled certificate required in the e-dossier.

3. The above 04 candidates are being given 1st opportunity w.e.f. 02/12/2021 to 11/12/2021.

4. The e-dossier link shall be activated to the above 04 pending candidates only for a period of 10 days w.e.f. 02/12/2021 to 11/12/2021.

5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **13.02.2020** as per Advertisement No. 02/2020.

6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
