Candidates for the post of PGT (Maths), Female, Post Code-29/20 and uploading e-dossier – regarding.

Reference Notice No. F. No. 271/Result/PGT (Maths)/Female/CC-III/DSSSB/2021-22/1218-26 dated 23.9.2021, the shortlisted candidates for the post of PGT (Maths) Female, post code-29/20 were asked to upload their documents in the e-dossier w.e.f. 28.09.2021 to 12.10.2021.

2. On scrutiny of the documents in the e-dossier, it has been noticed that the some of the candidates have uploaded their e-dossier with deficient documents and accordingly, their candidature has been kept pending for want of deficient / requisite documents in the e-dossier. Therefore, these candidates as per detail given below are being given 1<sup>st</sup> opportunity w.e.f. 29/10/2021 to 07/11/2021 to upload the deficient /requisite documents as mentioned against their roll numbers, in the e-dossier:-

In case, the candidate has not done B.Ed., than a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service(in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education).
2	111702900164	Passing date of M. Sc (Maths) has not mentioned in marks sheets of M.Sc (Maths). Hence, the candidate is directed to upload marks sheet/clarification mentioning passing date of M.Sc. (Maths) in e-dossier. The candidate should ensure that she fulfills all the eligibility criteria as on the cutoff date i.e. 13.02.2020.

- 3. The above 02 candidates are being given  $1^{st}$  opportunity w.e.f. 29/10/2021 to 07/11/2021.
- 4. The e-dossier link shall be activated to the above 02 pending candidates only for a period of 10 days w.e.f. 29/10/2021 to 07/11/2021.
- 5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 13.02.2020 as per Advertisement No. 02/2020.
- 6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on

the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions.
