NOTICE

Reference Notice No. F. No. 265/Result/ PGT (Comm.)/Male/CC-III/DSSSB/2021-22/2549-57 dated 01.9.2021, the shortlisted candidates for the post of PGT (Commerce) Male, post code-23/20 were asked to upload their documents in the e-dossier w.e.f. 08.09.2021 to 22.09.2021.

2. On scrutiny of the documents in the e-dossier, it has been noticed that the some of the candidates have uploaded their e-dossier with deficient documents and accordingly, their candidature had been kept pending for want of deficient / requisite documents in the e-dossier and accordingly, 61 candidates were given 1st opportunity w.e.f. 08/10/2021 to 17/10/2021 to upload the deficient /requisite documents. On further, scrutiny of the documents of the candidates for the post of PGT (Commerce) Male, Post Code-23/20, following 05 more candidates are found with deficient documents in the e-dossier and accordingly, these candidates are being given 1st opportunity to upload the deficient documents in the e-dossier as per details given against their roll numbers:-

1	11170400081	The candidate has not uploaded B.Ed. degree in the e-dossier. However, he has mentioned in OARS application form that B.Ed. done in 2018. But he has not uploaded any relevant documents with regard to B.Ed. degree. Therefore, B. Ed degree & its marks sheet are required in the e-dossier. In case, the candidate has not done B.Ed., than a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). The candidate is directed to upload the above documents in the single PDF file in the e-dossier whichever link is open for uploading of deficient documents in the e-dossier.
2	11180400056	The candidate has uploaded two OBC certificates. One OBC certificate No. 90500000499023 is applicable for applying for appointment to the posts under the Government of India and second OBC certificate No. 90500000300631 is issued on the basis of his father resident of Darbhanga, Bihar State. Both the certificates are not applicable for appointment in Govt. of NCT of Delhi. Hence, the candidate is directed to upload OBC (Delhi) certificate notified by Govt. of NCT of Delhi as per details/clarification given at para-5 of advertisement No. 02/2020.
3	11160400080	The candidate has uploaded OBC certificates No. 90500000275009 which is applicable for applying for appointment to the posts under the Government of India and not applicable for appointment in Govt. of NCT of Delhi. Hence, the candidate is directed to upload OBC (Delhi) certificate notified by Govt. of NCT of Delhi as per details/Clarification given at para-5 of advertisement No. 02/2020.
4	11300400007	The candidate has uploaded Diploma in Elementary Education instead of B.Ed. degree. Therefore, B. Ed degree & its marks sheet are required in the e-dossier.

3. The above 04 candidates are being given 1st opportunity w.e.f. 30/11/2021 to 09/12/2021.
4. **The e-dossier link shall be activated to the above 04 pending candidates only for a period of 10 days w.e.f. 30/11/2021 to 09/12/2021.**
5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **13.02.2020** as per Advertisement No. 02/2020.
6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
