1	111503500052	The candidate has not uploaded Master Degree in Psychology & its marks sheets with Diploma in Guidance & Counseling & its marks sheets which is essential requirement for the post as per RRs.
2	121103500051	M.A. (Psychology) done in December, 2020 which is after cutoff date. Hence, the candidate is directed to upload Master degree in psychology as on cutoff date i.e. 23.02.2020.
3	121203500136	M.A. (Psychology) and its marks sheet required in the e-dossier.
4	121103500040	M.A. (Psychology) done in May, 2020 which is after cutoff date. Further, Diploma in Guidance and Counseling done in June, 2021 which is also after cutoff date. Hence, the candidate is directed to upload Master degree in psychology & Diploma in guidance and counseling as on cutoff date i.e. 23.02.2020.

- 3. The above 04 candidates are being given 1st opportunity w.e.f. 08/12/2021 to 17/12/2021.
- 4. The e-dossier link shall be activated to the above 04 pending candidates only for a period of 10 days w.e.f. 08/12/2021 to 17/12/2021.
- 5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **23.02.2020** as per Advertisement No. 04/2020.
- 6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
