Subject:- Declaration of Marks of offline examination held on 03.11. 2019 for the Post of Driver (Male) (Heavy Motor Vehicle) in Department of NCC under Post Code-72/12 & shortlisting of candidates on the basis of written examination for skill test (Driving Test) - regarding.

The DSSSB vide its advertisement No. 02/12 had advertised 07 (UR-6, OBC-01 including ExSM-01) for the post of **Driver (Male) (Heavy Motor Vehicle) in Department of NCC under Post Code-72/12**. Tier-I offline written examination was held on 03.11.2019.

2. The marks obtained by 15 candidate who duly appeared in examination conducted (offline mode) on 03.11.2019 have been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.

3. Based on the performance in the examination, only 02 candidates have been provisionally shortlisted to skill test (Driving Test) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in his online application forms. The shortlisted candidate shall be called for Skill Test (Driving Test) separately.

Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Skill Test (Driving Test) does not entitled them any right over the post.

5. Reserved category candidates who have obtained marks above or equal to last shortlisted UR candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, otherwise for selection in their respective category, subject to availability of vacancies.

6. As per the Board notice dated 26.04.2013, the minimum qualifying marks in one Tier written examination for different categories are as under:-

UR/General : 40%;
OBC : 35%,
SC/ST/PH : 30%.

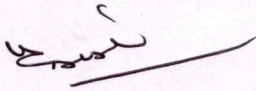
Ex-Servicemen : will be given 5% relaxation in their respective categories subject to a minimum of 30%

7. The shortlisted candidates for the above mentioned post code will be informed separately for appearing in the Skill Test (Driving Test) shortly.

8. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
