## NOTICE

Subject:- Declaration of Result of Driving Skill Test held on 15.02.2021, 16.02.2021 & 17.02.2021 and Uploading of e-dossier from the shortlisted candidates for the Post of Staff Car Driver under Post Code-154/14 in Delhi Prisons- regarding.

The DSSSB vide its advertisement No. 01/14 had advertised **07 vacancy (UR-04, OBC-02, SC-01)** for the post of **Staff Car Driver, Post Code-154/14 in Delhi Prisons**. The date of opening of application for was 27.01.2014 with closing date of 27.02.2014. The written examination in offline mode was held on 24.11.2019.

- 2. The marks obtained by 393 candidates duly appeared in examination (offline) conducted on 24.11.2019 have already been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 3. Further, as per Recruitment Rules for the post code-154/14, Driving Skill Test of 109 qualified shortlisted candidates was held on 15.02.2021, 16.02.2021 & 17.02.2021 who qualified in the written examination. Out of which 24 candidates having roll number given below have qualified the Driving Skill Test for the post of Driver, Post Code-154/14 in Delhi Prisons held at IDTR, Adjoining Loni Road Flyover, Main Wazirabad Road, Delhi-110094 and IDTR, Adjoining ISBT, Sarai Kale Khan, main Road Ring Road, Delhi-110013 on 15.02.2021, 16.02.2021 & 17.02.2021:-

- 6. Accordingly, based on the performance in the written examination held on 17.11.2019 as well as Driving Skill Test held on 15.02.2021, 16.02.2021 & 17.02.2021, **Twenty Three (23)** candidates are being provisionally shortlisted and allowed to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
- 7. The category wise cutoff marks (who qualified Driving Skill Test) for uploading e-dossier have been given as under:-

- 8. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards/Driving License etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing of candidates is being made on the basis of marks obtained in Tier-I written examination (Objective-MCQ) for 200 marks & Driving Skill Test in qualifying nature.
- 9. Kindly note that the e-dossier link will be activated to only those candidates who qualified in Driving Skill Test held on 15.02.2021, 16.02.2021 & 17.02.2021 and are in the consideration zone of selection.
- 10. The candidates who have been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 11. The e-dossier link shall be activated for a period of 15 days w.e.f. 23/03/2021 to 06/04/2021.
- 12. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 27.02.2014 as per Advertisement No. 01/14. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile

number & e-mail id. (as an additional facility). If, the candidate fails to upload the edossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.

- 13. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
