TGT (SOCIAL SCIENCE) MALE, POST CODE-137/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 303 [UR-163, OBC-62, SC-32, ST-46, including PH (OH-05, VH-04)] vacancies for the post of TGT (Social Science) Male, Post Code-137/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in offline examination mode was conducted on 09/09/2018.

- 2. On the basis of offline examination of Tier-1 held on 09.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Social Science) Male, Post Code-137/17 in Directorate of Education, a total of 282 (UR-157, OBC-50, SC-31, ST-44 including 06 PH) candidates were provisionally nominated for the post of TGT (Social Science) Male, Post Code-137/17 vide Result Notice No. 452 dated 28.05.2019 and the candidature of 12 candidates (UR-06, OBC-03, SC-01, ST-02 including 03 PH) was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. 31.05.2019 to 09.06.2019 and 02 candidates were kept pending for court case. Further, 14 candidates (UR-04, OBC-07, SC-02, ST-01 inc. 02 PH) were provisionally nominated vide Supplementary Result Notice No. 515 dated 25/09/2019. Further, 51 candidates (UR-25 inc. 01 PH, OBC-09, SC-11, ST-06) were provisionally nominated vide Supplementary Result Notice No. 674 dated 25.09.2020 against 62 dossiers returned by the User Department vide letter dated 26/12/2019, 15.01.2020, 06.03.2020, 17.03.2020 & 28.07.2020. The candidature of 08 candidates was kept pending for want of deficient documents and 02 vacancies were have been kept pending for court case candidates. Therefore, 07 candidates (UR-04, OBC-02, ST-01 including 02 PH (OH) under UR category) were provisionally nominated vide Supplementary Result Notice No. 738 dated 21.12.2020 and the candidature of 01 candidate was kept pending for want of deficient documents in the e-dossier.
- 3. Further, the User Department vide letter dated 28.07.2020, 19.09.2020 & 27.10.2020 had returned 06 dossiers (UR-02, OBC-04) of the candidates after cancellation of their candidature and hence, 06 vacancies have been created in their respective category due to return of these dossiers. These dossiers were returned after expiry of waiting panel. However, the Competent Authority has approved the extension of waiting panel upto 31.12.2020 and therefore, the candidates from the waiting panel in their respective category have been considered for nomination. The candidate who was kept pending for want of deficient documents has also uploaded the deficient documents in the e-dossier. He has also now been considered for nomination.
- 4. Accordingly, in continuation to Result Notice No. 452 dated 28.05.2019, Supplementary Result Notice No. 515 dated 25.09.2020, Supplementary Result Notice No. 674 dated 25.09.2020 & Supplementary Result Notice No. 738 dated 21.12.2020, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 09.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Social Science) Male, Post Code-137/17 in Directorate of Education.

- 5. The selection of the above 03 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M.

The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The result process for the above post code stands closed in all respect except 02 vacancies for court case candidates.
- **12.** Waiting panel which was valid for a period of one year from the date of declaration of result i.e. upto **27.05.2020** has been expired on 27.05.2020 as per earlier result notice no. 452 dated 28.05.2019. However, the same has been extended upto 31.12.2020.
- 13. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
