SUPPLEMENTARY RESULT NOTICE NO: 761 DATED 18.03.2021

PHYSICAL EDUCATION TEACHER, POST CODE-90/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 919 [UR-465, OBC-244, SC-141, ST-69] vacancies for the post of **Physical Education Teacher, Post Code-90/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in offline written examination mode was conducted on **16/09/2018**.

2. On the basis of offline examination of Tier-1 held on **16.09.2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **Physical Education Teacher, Post Code-90/17** in Directorate of Education, a total of **725 (UR-449, OBC-113, SC-138, ST-25)** candidates were provisionally nominated for the post of **Physical Education Teacher, Post Code-90/17** vide Result Notice No. **461** dated **30.05.2019** and the candidature of 34 candidates (UR-16, OBC-14, SC-03, ST-01) category was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. **06.06.2019 to 15.06.2019**. Further, **25 candidates** (UR-12, OBC-10, SC-02, ST-01) were nominated vide Supplementary Result notice No. 518 dated 27.09.2019 and **45 candidates** were provisionally nominated vide Supplementary Result Notice No. 627 dated 12.06.2020 against dossiers returned by the user department and 09 vacancies were kept pending for want of deficient documents in the e-dossier. Thereafter, **01 candidate** under UR category was provisionally nominated vide Supplementary Result Notice No. 659 dated 28.08.2020 and 07 candidates were rejected for not uploading of deficient/requisite documents in the e-dossier. Thereafter, 01 candidate under UR category was provisionally nominated vide Supplementary Result Notice No. 737 dated 21.12.2020. One vacancy was kept in abeyance under SC category.

3. Further, the User Department i.e. Directorate of Education vide letters dated 21.07.2020, 07.08.2020, 20.08.2020, 23.10.2020 & 01.12.2020 had returned **34 dossiers** (UR-24, OBC-01, SC-07, ST-02) of the candidates after cancellation of their candidature and requested to provide substitute candidate from the waiting panel. However, as these dossiers were returned after expiry of waiting pane, the candidates from waiting panel could not be considered against these returned dossiers. The Competent Authority, however, has extended the validity of waiting panel upto 31.12.2020. Therefore, the candidates from waiting panel have been taken into consideration for nomination as per their eligibility/uploading of e-dossier/merit against returned dossiers.

4. Accordingly, in continuation to Result Notice No. **461** dated **30.06.2019**, Supplementary Result Notice No. **518** dated **27.09.2019**, Supplementary Result Notice No. **627** dated **12.06.2020**, Supplementary Result Notice no. **659** dated **28.08.2020** & Supplementary Result Notice no. **737** dated **21.12.2020**, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 16.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **Physical Education Teacher Post Code-90/17** in Directorate of Education.

5. The selection of the above 08 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify

the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

11. The result process for the above post code stands closed in all respect.

12. The waiting panel was valid for a period of one year from the date of declaration of result i.e. upto **29.05.2020** as per earlier result notice no. 461 dated 30.05.2019. However, the same has been extended upto 31.12.2020.

13. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

14. The category wise marks obtained by the last selected candidates have been given as under:-

Note:- In advertisement no. 04/17, in para-2 (vii) - Mode of Selection (Examination Scheme), it has been clarified that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference. In case of further tie, candidate having higher marks in Section "A" of the test shall be preferred".
