TGT (SOCIAL SCIENCE) FEMALE, POST CODE-138/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised a total of **300** [UR-182, OBC-75, SC-18, ST-25, including PH (OH-04, VH-05)] vacancies for the post of **TGT (Social Science) Female, Post Code-138/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on **15/10/2018**, **16/10/2018** & **11/11/2018**.

- On the basis of online examination of Tier-1 held on 15/10/2018, 16/10/2018 & 11/11/2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Social Science) Female, Post Code-138/17 in Directorate of Education, a total of 284 (UR-178, OBC-64, SC-18, ST-24 including 06 PH) candidates were provisionally nominated for the post of TGT (Social Science) Female, Post Code-138/17 vide Result Notice No. 446 dated 27.05.2019 and the candidature of 07 candidates (UR-03, OBC-03, ST-01) was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. 30.05.2019 to 08.06.2019 and 08 candidates under OBC category were kept pending for verification of their OBC (Delhi) status. Thereafter, a total of 13 candidates (UR-01, UR/PH (VH)-01, OBC-09, OBC/PH/(OH), ST-01) were provisionally nominated vide Supplementary Result Notice No. 525 dated 01/10/2019 and 02 candidates were kept pending for want of deficient documents in the e-dossier by giving them 2nd and final opportunity w.e.f. 04/10/2019 to 10/10/2019. Further, 02 candidates (UR-01, OBC-01) were provisionally nominated vide Supplementary Result Notice No. 549 dated 03.12.2019. Thereafter, 30 candidates (UR-21, OBC-04, SC-03, ST-02) were provisionally nominated from the waiting panel against dossiers returned by the User Department vide letter dated 27.12.2019.
- 3. Now, the User Department has returned 21 dossiers vide letter dated 06.03.2020, 29.06.2020, 01.07.2020 & 13.07.2020 and requested to provide substitute candidate from the waiting panel. However, out of 21 dossiers returned, 11 dossiers are returned before expiry of waiting panel and therefore, the candidates in waiting panel are being taken into consideration for nomination in their respective category against 11 dossiers which received before expiry of waiting panel.
- 4. (i) Accordingly, in continuation to Result Notice No. 446 dated 27.05.2019, Supplementary Result Notice No. 525 dated 01/10/2019, Supplementary Result Notice No. 549 dated 03/12/2019 & Supplementary Result Notice No. 622 dated 18.03.2020. the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 15/10/2018, 16/10/2018 & 11/11/2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Social Science) Female, Post Code-138/17 in Directorate of Education:-

- 5. The selection of the above 10 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is

requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The candidature of one candidate has been kept pending for want of deficient documents in the e-dossier. She is being given 1st opportunity to upload the deficient documents w.e.f. 11/12/2020 to 20/12/2020.
