DATA ENTRY OPERATOR
UNDER POST CODE- 41/15 IN DAMB

1. The DSSSB vide its advertisement No. 01/15 had advertised 17 vacancies (UR-10, OBC-03, SC-03, ST-01 including PH-HH-01) for the Post of Data Entry Operator under Post Code 41/15 in DAMB.
2. The written examination (online mode) was conducted on 05.10.2019.
3. On qualifying Written Examination, vide Notice No. 933 dated 12.12.2019, the DSSSB has shortlisted 171 candidates for appearing in Skill Test/Typing Test for the post of Data Entry Operator Grade Under Post Code 41/15 in DAMB. The Skill Test was conducted on 25.02.2021 wherein out of 171 candidates, 120 candidates appeared for the skill test. In the said Skill Test conducted on 25.02.2021, out of 120 candidates only 115 candidates could qualify.
4. As per RRs prescribed for the said post the candidate has to attain typing speed of more than 8000 key depressions per hour to qualify in the skill test.

Based on the performance in the written examination and being qualified in Skill Test, **46 candidates (UR-22, OBC-10, SC-10, ST-03 & PH-HH-UR-01)** out of the above 115 candidates, who have qualified the skill test in their respective category, as per details given below, are being provisionally shortlisted and accordingly allowed to up-load their e-dossier, subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms:

7. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the requisite documents of Educational Certificate/Professional/Degree and Marks sheets/Caste Certificate/ Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as per RRs and as applicable, in e-dossier module in OARS link in their individual accounts in OARS module. Shortlisting is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and also qualified in skill test. E-dossier link shall be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 5 above.
8. The e-dossier link shall be active from **17.04.2021 to 01.05.2021**. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the said Post as on date of closing date of application, i.e. **26.11.2015**.
9. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID **as an additional facility**. If any candidate fails to upload the e-dossier during the said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
10. All the candidates who have shortlisted for uploading e-dossiers **MUST** upload their all requisite/applicable documents in the said link in stipulated time.
11. **Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit (based on marks attained in Tier-I/Written Exam) against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.**
12. The above short listing of candidates for calling of e-dossier for the said post will be subject to outcome of pending court cases or other relevant court cases, if any.



13. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
