Subject :- Result of Skill Test (Typing) and shortlisting of candidates for calling of e-dossiers for the Post of Field Clerk under Post Code 70/24 in Directorate of Civil Defence.

1. The DSSSB vide its advertisement No. 05/24 dated 05.03.2024 read with corrigendum 08.07.2025 had advertised Total- 05 Vacancies (UR-04 & OBC-01) for the Post of Field Clerk under Post Code- 70/24 in Directorate of Civil Defence.
2. The written examination (online mode) Tier-I for recruitment in respect of the said post was conducted on 24.06.2025.
3. On qualifying written examination (online mode), vide Result Notice No. 105 dated 24.11.2025 the DSSSB shortlisted 35 candidates for appearing in Skill Test for the Post of Field Clerk under Post Code -70/24 in Directorate of Civil Defence.
4. The Skill Test has been conducted on 08.02.2026, wherein out of total 35 candidates, 32 candidates appeared. Only 08 candidates could qualify in Skill Test.
5. **The Roll numbers of 08 candidates who have qualified the Skill Test for the Post Code-70/24 are as follows :-**

6. Based on the performance in the written examination and being qualified in Skill Test for post code 70/24, the candidates, as per details given below are being provisionally shortlisted for calling of e-dossiers and allowed to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms :-

7. As per the Examination Scheme, the provisional shortlisting is being made on the marks obtained in online Tier-I examination and the provisionally shortlisted candidates qualified in Skill Test (Typing Test).
8. Reserved Category candidates who have obtained marks above or equal to the

last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.

9. The shortlisted candidates for the above-mentioned post/ post code are hereby informed to fill the e-dossier and upload all the requisite documents as per advertisement.
10. Kindly note that the e-dossier link will be activated in r/o only those candidates who are provisionally shortlisted to upload e-dossier as per details given in Para 05 & 06 above.
11. All the candidates who have been shortlisted for uploading e-dossier **MUST** upload their all requisite/applicable documents in the said link within the stipulated time period.
12. The e-dossier link shall be active from **17.07.2026 to 31.07.2026**. The candidate uploading e-dossier should ensure that he/she fulfils all the eligibility criteria/all essential qualifications as per RRs for the said post as on closing date of application i.e. 17.04.2024.
13. The above short-listed candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID **as an additional facility**. If any candidate fails to upload the e-dossier during the above period, his candidature will be rejected and no further opportunity will be given on whatsoever ground.
14. Further, in case the candidates are unable to upload the documents within above stipulated time period due to any technical glitch in OARS module, they may report the same alongwith supporting evidence such as screenshots to e-mail of DSSSB helpdesk i.e. helpdesk-dsssb@delhi.gov.in. The technical glitch shall be substantiated/ verified and only then, an additional period of three days will be granted for uploading the documents in e-dossier system.
15. Mere asking the candidate for uploading documents in the e-dossier module does not confer him right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the requisite eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned above he will not be given any further opportunity and his candidature will be treated as cancelled.
16. The above short-listing for calling of e-dossier for the post of Field Clerk under Post Code- 70/24 in Directorate of Civil Defence, will be subject to outcome of pending court cases if any.
17. While every care has been taken in preparing the above shortlisting, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
