1. The candidates may please refer to the DSSSB advertisement no. 0224 dated 12.01.2024 available on Board's website, advertising Total- 803 vacancies Including PwBD -28 [UR-431, EWS-13, OBC-66, SC-32 & ST-261] for the Post of **TGT-English (Male/Female) under Post Code- 804/24 in DOE & NDMC** under Combined Examination Scheme.
2. Vide said Advertisement, under Combined Examination Scheme, it has to be ensure that –“**The candidate must exercise at least one preference for a Post. Candidates, who don't submit their Post Preference within the stipulated time, will not be considered for any Post in the final result. Such candidates shall not be provided another opportunity to exercise preference for Posts**”. Further, “**Final selection and allocation of department by DSSSB shall be based on merit cum preference only. The User Department shall check the eligibility as per RRs and other terms and conditions of the Advertisement Notice**”.
3. The marks obtained by 14799 out of 14802 **candidates** who appeared in CBT held on 24.08.2025, 30.08.2025 & 31.08.2025 were uploaded on Board's website vide **Notice No. 167 dated 22.05.2026**. Out of 14802, total 1545 candidates were shortlisted to select their preference of Departments and upload the documents in e-dossier module – OARS from the period **26.05.2026 to 09.06.2026** subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form. **Out of 1545 candidates total 1513 candidates have uploaded their documents and preference in OARS module.** Candidature of rest of the 32 candidates who have not uploaded their e-dossier within stipulated time has been rejected vide **Rejection Notice No. 191 dated 28.07.2026**.
4. As per the provisions of Notice No. 167 dated 22.05.2026, allocations of the post to eligible candidates have been made on the basis of Merit-cum-Preference of posts submitted by the candidates in their PREFERENCE FORM uploaded in e-dossier OARS module.
5. As per the Board (DSSSB) resolution dated 14.7.2022, DSSSB shall neither undertake scrutiny of documents uploaded by the shortlisted candidates in their e-dossier nor check the eligibility of the candidates as per the Recruitment Rules for the post or the terms and conditions stipulated in the Vacancy Notice relating to age, experience, educational qualification, reserved category status, PwBD status etc. These will be checked by the User Department at the time of Document verification for deciding the eligibility of the candidate for the post Code 804/24 as on cut-off date 14.02.2025, before issuance of offer of appointment to the candidate.
6. On the basis of marks secured in the written examination and considering other relaxations, if any, claimed by the candidates in their online application forms, **Total 794 candidates in Directorate of Education and NDMC [in DOE-783 (FOR MALE- 409 i.e. UR- 222(incl. PwBD sub cat a-03, b-01, c-03), EWS-02, OBC-42, SC-25 (incl. PwBD sub cat a-01), ST-118 and FOR FEMALE – 374 i.e. UR- 200 (incl. PwBD sub cat a-02, b-01, c-04 and d&e-C3), EWS-09, OBC-22 (incl. PwBD sub cat b-01), SC-04, ST-139) and in NDMC- 11 (UR-03, EWS-02, OBC-02, SC-03 and ST-01)]** candidates are hereby **provisionally nominated** for the Post under Post Code 804/24 subject to fulfillment of all other conditions of eligibility and also correctness of the information furnished by the candidate in his/her online applications form and e-dossier. PwBD sub cat a-03, b-01, c-03), EWS-02, OBC-42, SC-25 (incl. PwBD sub cat a-01), ST-118 and FOR FEMALE – 374 i.e. UR- 200 (incl. PwBD sub cat a-02, b-01, c-04 and d&e-03), EWS-09, OBC-22 (incl. PwBD sub cat b-01), SC-04, ST-139) and in NDMC- 11 (UR- 03, EWS-02, OBC-02, SC-03 and ST-01)]** on the basis of claims in their applications shall be subject to thorough verification of their candidature by the User Department including the identity of the candidate as per services department Circular No. F.16(3)/2007/S-III/1756-1763 dated 02/08/2021.
8. The provisional nomination of the above **Total 794 candidates in Directorate of Education and NDMC [in DOE-783 (FOR MALE- 409 i.e. UR- 222(incl. PwBD sub cat a-03, b-01, c-03), EWS-02, OBC-42, SC-25 (incl. PwBD sub cat a-01), ST-118 and FOR FEMALE – 374 i.e. UR- 200 (incl. PwBD sub cat a-02, b-01, c-04 and d&e-03), EWS-09, OBC-22 (incl. PwBD sub cat b-01), SC-04, ST-139) and in NDMC- 11 (UR- 03, EWS-02, OBC-02, SC-03 and ST-01)]** shall further be subject to genuineness of the documents on the basis of which they have claimed to fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement and subject to thorough verification of their identity with reference to their photographs, signature/ handwriting etc. on the application form, admission certificate etc. by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. 12. In case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions/ guidelines issued from time to time in this regard by the competent authorities.
13. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after verification of the correctness of the information furnished in the application form/e-

dossier and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide **MHA OM No. 2/29/54-RPS, 19/11/54 and other relevant guidelines/ OMs/Circulars issued by the competent authority.**

14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
