DSSSB conducted written examination for recruitment to the post of PGT Urdu (post code 155/12, 156/12, 191/14) in Directorate of Education. Based on performance in Tier-I written examination the candidates (as per list attached) have been shortlisted to appear in Tier-II Exam, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in the OARS (Online Application Registration System).

Reserved category candidates (OBC, SC/ST) have been shortlisted for appearing in Tier-II Exam. on the basis of details provided by them in OARS as well as in OMR answer sheets. Since documents have not been called from the candidates alongwith application as such detailed scrutiny regarding their eligibility has not been carried out and therefore mere inclusion of names in the list for qualifying the candidates for appearing in Tier-II Exam does not entitle the candidates any right over the post.

The candidates shortlisted for appearing in Tier-II Exam. is purely provisional subject to verification of credentials, for determination of eligibility for the post to be carried out by the Board after completion of Tier-II Exam

Aforesaid above reserved category candidates shortlisted in UR category in written Examination who obtained marks above or equal to the last qualified UR candidates have been declared qualified for appearing in Tier-II Exam against the UR vacancies and their final selection to the post shall be considered in UR category, subject to the availability of vacancies, otherwise in their respective category, if eligible otherwise for selection in said category.

The number of qualified candidates for appearing in Tier-II Exam has been done in the ratio 1:10 of the advertised vacancies with taking all the candidates who have scored marks equal to the cut off marks for each category for short listing. Final selection against advertised vacancies shall be made in accordance with the merit list drawn as per result of the written examination subject to availability of vacancies and the candidates qualifying

the Tier-II Exam and also fulfilling of all conditions of eligibility as prescribed by the RRs of the User Department and terms & conditions of advertisement.

Shortlisted candidates whose Roll Numbers are indicated in the result notice will be called for Tier-II Exam separately.

For preparation of merit list, date of birth specified by the candidate in OARS has been considered.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
