Candidates for the post of PGT (English), Female, Post Code-26/20 and uploading e-dossier – regarding.

Reference Notice No. F. No. 268/Result/ PGT (Eng.)/Female/CC-III/DSSSB/2021-22/2537-45 dated 01.9.2021, the shortlisted candidates for the post of PGT (English) Female, post code-26/20 were asked to upload their documents in the e-dossier w.e.f. 06.09.2021 to 20.09.2021.

2. On scrutiny of the documents in the e-dossier, it has been noticed that the 52 candidates have uploaded their e-dossier with deficient documents and accordingly, their candidature was been kept pending for want of deficient / requisite documents in the e-dossier. Accordingly, they were given 1<sup>st</sup> opportunity w.e.f. 08/10/2021 to 17/10/2021 to upload the deficient /requisite documents. However, out of 52 pending candidates, the following 03 candidates are still kept pending for want of deficient /requisite documents in the e-dossier as mentioned against their roll numbers, in the e-dossier:-

3. The above 04 candidates are being given 2<sup>nd</sup> opportunity w.e.f. 29/11/2021 to 03/12/2021 to upload the deficient /requisite documents in the e-dossier, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground.

- 4. The e-dossier link shall be activated to the above 05 pending candidates only for a period of 05 days w.e.f. 29/11/2021 to 03/12 /2021.
- 5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 13.02.2020 as per Advertisement No. 02/2020.
- 6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
