**ORDER**

Whereas the Board vide its advertisement No.02/21 had advertised **total-120 vacancies** (EWS-35, UR-45, OBC-17, SC-16, ST-07 Including PwD: OH-01, VH-02, HH-02) for the Post of **ASSISTANT TEACHER (PRIMARY) under Post Code- 47/21 in New Delhi Municipal Council** and conducted Tier-I examination (online mode) for recruitment on **23.03.2021, 24.03.2021, 25.03.2021 & 26.03.2021.**

And whereas, **Suresh Chand Dhakar (Roll No. 112004703010)**, candidate for the post of Assistant Teacher (Primary) under post code-47/21 in New Delhi Municipal Council had applied under OBC (OS)/UR, sub category-PHOB and appeared in the online written examination held on 25.03.2022 & scored 121.70 marks in written examination.

Whereas on the performance in the written examination, the qualified candidates who obtained marks above or equal to minimum qualify marks in their respective category were shortlisted for uploading of e-dossier subject to attaining the minimum qualifying marks and correctness of the information furnished by the candidate in their online application forms. The cutoff marks for uploading of e-dossier were as EWS-143.44 marks, UR-157.19, OBC-150.06, SC-145.48, ST-127.69 & PwD-104.09 marks.

And whereas, the candidature of Suresh Chand Dhakar (Roll No. 112004703010), could not come under UR category for being lower in merit but as he had applied under PHOB category, he was shortlisted under PwD category for uploading of e-dossier as Physically disabled candidate. Even though, the candidate had applied under PHOB category but it could not be clarified in online application form that as to whether he belongs to PH (OH-Ortho), PH (VH-Visual) or PH (HH-Hearing) category. Accordingly, all such candidates who applied under PHOB & PHSC category were directed vide notice dated 16.08.2022 to upload their specific physically disabled certificate i.e OH/VH/HH category in the e-dossier as they have not mentioned their specific category in OARS.

And whereas the candidate has also not uploaded any physically disabled certificate in the e-dossier which can prove that in which sub category he belongs to. But the candidate failed to upload any disability certificate in the e-dossier within stipulated time period. Further, a question was raised that if he does not belong to PH category then as to whether he had availed extra time in written examination which is applicable only for PH candidates. After taking candidate's log details from EdCIL by which he had given written examination on 25.03.2022 it is found that Suresh Chand Dhakar (Roll No. 112004703010) had availed extra 40 minutes time in the online written examination for which he was not entitled as he belongs to OBC (OS)/ UR category and did not belong to PH sub-category.

And whereas, the candidate Suresh Chand Dhakar (Roll No. 112004703010) has given false information in OARS by filling PHOB category and availed 40 minutes extra time more of stipulated 02 hours in written examination which is only applicable to PwD category candidates. He also gave a declaration in his own handwriting in English on page 2 of Photo attendance

sheet that "I certify that I am the person whose name Roll No. and Photograph appear above on this e-admit card. I hereby declare that the information given in this application is true and correct to the best of my knowledge and belief. In case any information given in this application proves to be false or incorrect, I shall be responsible for the consequences".

Therefore, the candidature of **Suresh Chand Dhakar (Roll No. 112004703010)** is rejected in all respect for the post of Assistant Teacher (Primary) under post code-47/21 in New Delhi Municipal Council.
