## RESULT NOTICE NO. 1183 WILD LIFE INSPECTOR (POST CODE 67/14) IN FOREST AND WILD LIFE DEPARTMENT

- The DSSSB vide its Advertisement No. 01/14 with closing date 27/02/2014 had advertised 02 vacancies (UR-01, OBC-01) for the post of Wild Life Inspector in Forest and Wild Life Department under Post Code 67/14. Board Conducted Tier-I written examination for recruitment in respect of this post on 20/11/2019. Based on the performance in Tier-I written examination (online mode), vide Notice No. 967 dated 05/03/2020, 16 (Sixteen) candidates, were provisionally shortlisted to appear in Tier-II examination.
- 2. The online Tier II examination was held on 19/03/2021 and vide Notice No. 1134 dated 11/05/2021, the marks statements of the above Post/Post Code have been uploaded the Board's website for information of the candidates. Candidates can view their marks by logging onto their account in OARS module on www.dsssbonline.nic.in.
- On the basis of Tier-II examination held on 19/03/2021 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 01/2014 and RRs for the Post of Wild Life Inspector under post code 67/14 in Forest and Wild Life Department, the following Candidates are hereby provisionally nominated as per their merit:-

- \* Note:- That as per RRs, essential qualification is "Degree from a recognized University or its equivalent with fair knowledge and experience of wildlife", since the essential qualification related to fair knowledge and experience of wildlife is technical in nature therefore, at this stage DSSSB has not undertaken the veracity/scrutiny of the essential education qualification furnished by the candidates as such User Department i.e. Forest and Wild Life Department, GNCTD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate as per nature of job and requirements of the Department. The selection is provisional and subject to satisfaction of User Department regarding essential qualification furnished by above candidates.
- The selection of the above 02 candidates (UR-01, OBC-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- The Selection of the above 02 candidates (UR-01, OBC-01) shall further be subject to 5. genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough their verification of their identity with reference to signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Forest and Wild Life Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.



- The stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his / her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
- The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 12. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
