## NOTICE

PROVISIONALLY SHORTLISTED CANDIDATES FOR VERIFICATION OF DOCUMENTS UNDER POST CODES-PGT 149-150/12 AND 175-176/14 FOR THE POST OF PGT POLITCAL SCIENCE IN DIRECTORATE OF EDUCATION.

- 1. The Tier-II marks of the candidates for the post of PGT (Political Science) have been uploaded in the Board's Website.
- 2. The Board has started the facility for the candidates to enable them to upload their requisite documents in the Board's portal.
- 3. The candidates should check their marks on the Board's Website. A separate link has also been provided wherein the shortlisted candidates need to upload their edossier.
- 4. It may please be noted that the e-dossier link will be activated to only those candidates who have been shortlisted for falling in the consideration zone of selection.
- 5. All the candidates who have been shortlisted and are falling in the consideration zone of selection **MUST** upload their requisite documents in the said link.
- 6. An e-dossier Proforma (as enclosed) should also to be uploaded by each candidate mandatorily. Only the duly filled Proforma need to be uploaded. The Proforma need to be filled by the candidates in their own hand writing (except in the case of VH candidates).
- 7. The help file for uploading the document through e-dossiers has also been provided in the website. All concerned should go through it thoroughly before uploading their respective documents.
- 8. The e-dossier link shall be active only till **14.03.2017**, accordingly all concerned shall upload the requisite documents latest by 14.03.2017.
- 9. Details of the cut off marks above which candidates have been shortlisted are as under:
