## **ORDER**

Compliance of order/direction dated 17.02.2015 of the Hon'ble Central Administrative Tribunal as passed in OA 14/2012 titled as Mr.Gulab Singh V/s GNCTD & Ors.

The Hon'ble CAT in OA 14/2012, titled as Mr. Gulab SinghV/s GNCTD & ors. vide its order dated 17.02.2015 has directed as under:-

"In the circumstances and for the aforesaid reasons, the OA is allowed and the respondents are directed to consider the applicant for appointment to the post of TGT (English),as per his merit in the Ex Serviceman category, with all consequential benefits, except back wages, within sixty days from the date of receipt of a copy of the order."

In compliance of above order and in taking into consideration the representation dated June, 05, 2015 to Dy. C.M.(through e mail) forwarded to this office by A.D.E.(E-III) Directorate of Education GNCT, Delhi, the case of applicant Mr Gulab Singh, Roll No.0118646 has been re-examined and it is hereby observed that:-

- 1. The issue of age in Ex Service man Category of Gulab Singh, as ordered by Hon'ble CAT is accepted with humbleness and his dossier was examined before issuing the Result.
- 2. The applicant Mr. Gulab Singh had applied for the post of TGT (English) Male) under post code No.01/10. The DSSB conducted the examination for the said post code on 6.06.2010 and the result was declared on 11.3.2011. The candidate Gulab Singh obtained 109/200 marks in this examination and his result was "NE Overage" as per the scrutiny report.

<u>Essential qualification(s)</u> for the posts as indicated in the RRs of the post as supplied by the Directorate of Education are as under:-

Age:- Below 30 years (relaxable in case of Govt. Servants of Delhi Admn. up to 40 years (45 years for SC/ST employees) and up to 40 years in case of female Candidates) Two years extension to the upper age limit has been indicated in the requisition of Directorate because of increase in the age of retirement.

**Education Qualifications**:- (i) A Bachelor's Degree(Honours/Pass)or equivalent from a recognized University having secured 45% marks in aggregate, in two school subjects of which at least one out of the following should have been at the elective level.

 English 2. Mathematics 3.Natural/Physical Science 4.Social Science. Provided further that the requirement as to minimum of 45% in the aggregate at graduation level shall be relaxable in case of (a) Candidates who passes a Post Graduate Qualification in any of the

teach subjects listed above. (b) Candidates belonging to SC/ST/PH Category.

(ii) Degree /Diploma in teaching OR SAV Certificate.

(iii) Knowledge of Hindi is essential.

Provided that the Assistant Teacher from MCD/Dte of Education and Lab Assistants shall not be required to have received 45 % marks in aggregate in Bachelor's Degree (Pass/Honours) or equivalent

N.B. "The Candidate should have studied the subject concerned as mentioned in all parts/years of the graduation. The elective word may also include main subject as practiced in different universities."

- 3. The documents furnished by the candidate, available on file (dossier), were scrutinized and it has been observed that the applicant has passed B.A. (External) I/II in Mar./ April,1995 in one year from Osmania University. He has not studied English in all/both parts of his graduation. Accordingly he has not been found eligible for selection to the post of TGT (English) Male under the post code 01/2010 in Govt. of NCT of Delhi.
- 4. As the applicant does not possess the requisite essential eligibility criteria/ as per provision "The candidate should have studied the subject concerned as mentioned in RRs in all parts of the graduation. The elective word may also include main subject as practiced in different Universities "for the post mandates, English subject was not studied by the applicant in all/both parts of his graduation (B.A.),hence he is not eligible for selection to the post of TGT (English)Male.

In view of the above facts, the claim of the applicant Mr. Gulab Singh has been considered & examined for selection to the post of TGT (English) Male under post Code 01/10 & being not found eligible for the same, rejected.

This issues with prior approval of the competent authority.
