RESULT NOTICE
FIRE OPERATOR (P.C.-003/09)
DELHI FIRE SERVICES.

This is in pursuance to the directions of the Ld. CAT vide its order dated 09-12-2011 in OA 3131/2011 Pramod Dabas. Vs. GNCTD & Ors. **The Ld. CAT vide its above mentioned order has directed that:-**

“5. We find that the facts of this case are squarely covered by the direction given by this tribunal in earlier cases. Under the circumstances, we direct the Respondent No. 2 to examine the genuineness of the signature of the applicant with reference to the documents available with them or with reference to any other mode of verification they would choose to adopt. In case the verification shows that the signature of the applicant in block capital letters was genuine, then they shall forward the dossiers of the applicants to the Appointing Authority for consideration of their appointment to the post of Fire Operator in a prospective manner. In case their scrutiny reveals otherwise they may pass a reasoned order after giving due opportunity to the applicants.”

The brief facts of the present case are that the applicants had applied for the post of Fire Operator, Post Code 003/09 and was allotted Roll No. 00333370. He appeared in the examination of Fire Operator under post code 003/09. He was declared qualified in written tests, Physical Endurance Test (PET) and Driving Skill Test. However, the candidature of the applicant was rejected for having put his signatures in block capital letters on the application form/admit cards/answer sheets etc. in violation of the specific conditions laid down in the advertisement number 001/09.

Now, in compliance of the Ld. CAT's dated 09-12-2011 in OA 3131/2011 Pramod Dabas. Vs. GNCTD & Ors., the applicant/candidate is hereby provisionally selected and recommended for appointment to the post of Fire Operator, Post Code-003/09 in the Delhi Fire Services., in the pay scale of Rs. 4000-100-7100 (Pre-revised).

The selection of the candidate shall further be subject to fulfillment of all the eligibility conditions as prescribed by the statutory RR's and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of his identity with reference to his photographs, signature/handwriting etc. on the application form, admission certificates etc. The candidature of the candidate is liable to be cancelled by the user department also, in case the candidate is found not to be fulfilling the eligibility conditions or due to any other genuine reason. The **Competent Authority of the department concerned** shall issue the appointment letter to the candidate after satisfying themselves of his eligibility as laid down in the recruitment rules and

on verification of the correctness of the information/documents as furnished in the application form. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The result has been processed keeping in view the eligibility conditions regarding educational qualification/caste certificate as on cut off date i.e. 03-03-2009.

The user department shall also get the OBC certificate verified from the issuing authority before his appointment. Further, it may also be verified that the candidate does not belong to the persons/sections(Creamy layer) mentioned in column 3 of the Schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08-09-1993, O.M.No. 36033/3/2004-Estt(Res) dated 09-03-2004 and O.M.No.36033/3/2004-Estt(Res) dated 14-10-2008.
