**DELHI FIRE SERVICES.**

This is in pursuance to the directions of the Ld. CAT vide its orders in (i) OA No. 2874/2011 dated 05-12-2011 titled Sunil Kumar Vs. GNCTD & Ors. (ii) OA No. 3888/2011 titled Parveen Kumar Vs. GNCTD & Ors. (iii) OA No. 464/2012 Vs. GNCTD & Ors. and (iv) OA No. 4495/2011 titled as Sanjeev Shokeen Vs. GNCTD & Ors. The Ld. CAT vide its above orders has directed to declare the result of the applicants i.e. (i) Sh. Sunil Kumar S/o Sh. Dharam Pal (ii) Sh. Parveen Kumar S/o Sh. Shri Rajpal (iii) Sh. Sanjay Kumar S/o Sh. Sant Ram Singh and (iv) Sh. Sanjeev Shokeen S/o Sh. Ramesh Singh Shokeen and forward the dossiers of the applicants to the Appointing Authority for consideration of their appointment to the post of Fire Operator in a prospective manner

The brief facts of the present case are that the applicants had applied for the post of Fire Operator, Post Code 003/09. They appeared in the examination of Fire Operator under post code 003/09. They were declared qualified in written tests, Physical Endurance Test (PET) and Driving Skill Test. However, the candidature of the applicants was rejected for having put their signatures in block capital letters on the application form/admit cards/answer sheets etc. in violation of the specific conditions laid down in the advertisement number 001/09.

Now, in compliance of the Ld. CAT's orders as mentioned above, the applicants/candidates are hereby provisionally selected and recommended for appointment to the post of Fire Operator, Post Code-003/09 in the Delhi Fire Services., in the pay scale of Rs. 4000-100-7100 (Pre-revised).

The **Competent Authority of the department concerned** shall issue the appointment letter to the candidate after satisfying themselves of his eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents as furnished in the application form. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The result has been processed keeping in view the eligibility conditions regarding educational qualification/caste certificate as on cut off date i.e. 03-03-2009.

**The user department shall also get the SC/OBC certificate verified from the issuing authority before his appointment.** Further, in case of OBC candidate, it may also be verified that the candidate does not belong to the persons/sections(Creamy layer) mentioned in column 3 of the Schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08-09-1993, O.M.No. 36033/3/2004-Estt(Res) dated 09-03-2004 and O.M.No.36033/3/2004-Estt(Res) dated 14-10-2008.
