## ORDER

In compliance of the final orders of Hon'ble CAT dated 20/03/2015 passed in the aforementioned case of para (5) of which reads as under:

"We dispose of the aforementioned Original Applications with liberty to the applicants to make individual representations to the Board within one Week from today and a direction to the Board to decide the same within three weeks thereafter by way of reasoned and speaking order. It is made clear that the time limit of three weeks is outer limit for disposal of the representations and in such cases where the dates of interview have been finalized the respondents may consider the representation of priority No Costs".

The applicants were allowed one week time to resubmit their representation to the Board vide order dated 20/03/2015. The petitioner has submitted her representation.

In view of the above direction of the Hon'ble court, representations of the candidates have been examined and the reasons for rejection of the applications are as under:

- 1. Ms. Sonia submitted her representation dated 27/03/2015, received in this office on 06.04.2015 that she had applied for the post code 119/12 TGT (Social Science) Female.
- 2. Vide notices dated 24/10/2014, 17.11.2014, 25.11.2014 & 01.12.2014 Candidates for the post codes 106/12 to 121/12 etc. were required to register themselves in OARS software and upload their photographs, signature & educational qualifications/experience online for issuance of admit cards through OARS. Further, it was indicated that candidates who fail to register in OARS will not be issued admit cards candidates. Moreover, they must ensure that they fulfill all the eligibility criteria as per the advertisement No. 02/12 on or before the cut off date i.e. 15.06.2012. Opportunity for the same was provided to the candidates till 10.12.2014.
- 3. The candidate failed to do so. Hence E-admit card was not generated/downloaded by the candidate. Her candidature was rejected as she did not apply through OARS of the Board.

In view of above, the candidature of above said candidate for 119/12 stands rejected and as such her request cannot be accepted
