ORDER

1. Whereas, Ms. Anuradha Chauhan (Roll No. 111713801285, category-UR) had applied for the post of TGT (Social Science) Female under Post Code-138/17 advertised by Advertisement No. 04/2017. Since the candidate was falling under consideration zone, she was directed to upload her documents in e-dossier module vide notice dated 20/03/2019. She was also informed through SMS and email.
2. Whereas, On scrutiny of the documents uploaded by Ms. Anuradha Chauhan, it was found that she has qualified CTET on 04/01/2019 i.e. after the cut of date. Accordingly, her candidature was rejected vide rejection notice no.447 dated 27/08/2019.
3. Whereas, Ms. Anuradha Chauhan submitted a representation dated 10/04/2019 stating that she has also qualified CTET in the year 2011 but due to some confusion she did not upload the same. She has also enclosed copy of her CTET certificate dated 26.07.2011 qualified in elementary stage. Further, she has requested to give her one more opportunity to upload the CTET certificate and reconsider her candidature.
4. Whereas, Ms. Anuradha Chauhan, also approached the Hon'ble CAT vide O.A. No. 3028/2019 for redressal of her above said grievance.
5. Whereas, a large number of similarly placed candidates have represented that though they are having the CTET certificate issued before the cut off date but has uploaded the CTET certificate issued after cut off date. Keeping in mind the principle of natural justice, it was decided that these candidates be given a chance to upload their correct CTET certificates as per policy of the Board provided they have not exhausted stipulated two number of recalls admissible to each candidate. Accordingly, the representation of Ms. Anuradha Chauhan was considered for revival of her candidature.
6. Now therefore, the candidature of **Ms. Anuradha Chauhan (Roll No. 111713801285, category- UR) which was rejected vide rejection Notice No.447 dated 27/05/2019, is now being revived and she is directed to upload her CTET Certificate qualified before cut off date in the e dossier module within the stipulated time, i.e. from 21-10-2019 to 27-10-2019 as Board accepts all the documents from candidate only through e-dossier module.**

7. The e-dossier module link for above purpose shall be activated from **21-10-2019 to 27-10-2019.**
