Keeping in view the judgment dated 04.08.2009 of Hon'ble Supreme Court of India as passed in Civil Appeal No. 5092 of 2009 arising out of Petition (s) for Special Leave to Appeal (Civil) No(s). 24327/05 Subhash Chandra & Anr. V/s DSSSB & ors., result in respect of candidates Roll No. 8510338; 8510664; 8510343; 8510273; 8510617; 8510240; 8510055; 8510032 & 8510621 belonging to SC/ST categories with caste certificate of other States or caste certificates issued by the authorities of GNCT of Delhi based on the caste certificate of their parents of other states, have not been processed further.

Pending result of candidates with following Roll No. 8510692; 8510122; 8510277; 8510526; 8510269; 8510685; 8510396; 8510447; 8510027; 8510593 are also finalized and rejected, as none of the candidates were found meeting the eligibility criteria for the post as prescribed by the RRs.
