Alphabet 'P' is suffixed as his selection to the post is provisional subject to mandatory conditions that the candidate shall acquire B.Ed./B.T qualification within a period not exceeding three years from the date of their joining the service.

Further, the result of above candidate was kept pending in view of the information provided by him at the time of recasting of his dossier that he was in judicial Custody in dowry death case of his wife against him (after the filing of application form for the post) and got interim bail for submitting this application form.

Now ADE(E-II), Dte. of Education vide letter dated 21.5.2014 forwarded the representation of Sh Ashok Kumar alongwith bail order of Delhi High Court dated 23.4.2014 granting him bail.

Accordingly, the matter was put up to the competent authority and it was decided to provisionally recommend the candidate with the above mentioned facts to the user department for taking final decision in the case.

Hence, the recommendation of the candidate is strictly provisional subject to the further decision of the user Department with respect the facts of the case being appointing authority.

The Competent Authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The selection/appointment of above mentioned candidate shall further be subject to outcome any other court case in the matter.
