For admissibility of benefit of reservation the result has been processed as per the judgment dated 04.08.2009 of Hon'ble Supreme Court of India as passed in Civil Appeal No. 5092 of 2009

arising out of Petition (s) for Special Leave to Appeal (Civil) No(s). 24327/05 Subhash Chandra & Anr. V/s DSSSB & ors. As per above judgment, there being no Presidential notification under Article 342 of the Constitution of India for STs in the UT of Delhi, candidature in respect of ST candidates for ST category vacancies has been rejected. Similarly in SC category, SC candidates other than of Delhi origin have not been considered for admissibility of benefit of reservation as per above judgment. In OBC category as per instructions of GNCT of Delhi duly published in the advertisement inviting applications, only Delhi origin OBC candidates have been considered eligible for admissibility of benefit of reservation in OBC category.

For candidates against whom roll number alphabet 'P' is suffixed their selection to the post is provisional subject to mandatory condition that the candidates shall acquire B.Ed./B.T. qualification within a period not exceeding three years from the date of their joining the service.

The result of candidates bearing roll no 01010119, 01210927, 01310846, 01310411 and 01710371 are pending for verification of identity/completion of documentations etc., candidates are directed to contact the office of the Board within 10 days of declaration of the result for further action with all their credentials.

Selection of above 52 candidates (UR-29 OBC-14,, SC-07 , VH-01 & PH-01) shall further be subject to fulfillment of all eligibility conditions by the candidates as prescribed by the statutory RRs and term and conditions of advertisement as indicted in the advertisement inviting applications and also subject to through verification of their identity with reference to their photographs, signatures, handwriting and thumb impression etc., on the application forms, admission certificates etc. The candidature of the candidates is liable to be cancelled by the user Department also, in case candidates found not fulfilling the eligibility conditions or any other genuine reasons. The competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form by the candidates by verification of the same from original documents. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
