POST GRADUATE TEACHER (HINDI) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 137/2012

The DSSSB vide its advertisement No 02/2012 with closing date 15.06.2012, had advertised 78 vacancies (UR-43, OBC-22, SC-13 including OH-01, VH-01) for the post of *Post Graduate Teacher (Hindi) (Female)* in Directorate of Education under **Post code 137/12** in the pay scale of Rs. 9300-34800/- having Grade Pay of 4800/- (Pre- revised) (Non- Gazetted). The Board had conducted Tier I examination on 30.11.2014. The Tier II examination held on 28.06.2015 was cancelled vide Notice dated 30.07.2015 and was again conducted on 26.06.2016.

The marks of Tier-II examination was declared vide Notice No. 545 dated 06.10.2017 and dossiers from the shortlisted candidates have been obtained. On the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Hindi) Female

The candidature of the candidate having Roll Number 22008584 is cancelled as she has not uploaded her documents in e- dossier module in compliance with Notice No. 545 dated 06.10.2017. Further the candidature of candidate having Roll No.22007931 is rejected as the candidate is not qualified on cut off date.

The candidature of the candidates having Roll Number 22001682, 22007855 are kept pending in UR category for submission of their BEd details. The candidature of the candidate having Roll Number 22001461 is pending in OBC category for submission of her MA passing details. Candidature of candidates having roll number 22007255, 22008357, 22008081, 22007663 and 22007658 has been kept pending for verification of their OBC certificates. Candidature of candidate having Roll No.22000170 is pending in UR/OH category for submission of Disability certificate.

One post in UR category, two posts in OBC category and two posts in SC category have been kept withheld in view of pending court cases having OA No-2225/15, 2139/16, 2420/15 and 2178/15 to consider the claims of applicants, who were provisionally allowed to appear in Tier –II examination and their marks have been kept in sealed cover, in case Ld. CAT issues necessary orders in their favour.

The candidatures of the candidates having Roll No.22008713, 22003532, 22005851, 22004332, 22006226 & 22004167 have been verified that they had applied for post code 137/2012. Accordingly their candidature are considered in post code 137/2012. In compliance with their related court orders their marks have been uploaded in the Boards website. Further in compliance Ld. CAT order dated 17.11.2017 in OA No. 2242/2015 in the matter of Sh. Arjun Singh and ors vs GNCTD, the marks of candidate having Roll No.22005728 is also uploaded on the Boards website. All these candidates may view their logging into their account in OARS module marks bv www.dsssbonline.nic.in. None of these candidates is in zone of selection on account of their lower merit in their respective categories.

The selection of the above 63 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
