- 1. The DSSSB vide its advertisement No. 01/2015 had advertised total **91** vacancies {UR-48, OBC-24, SC-13 & ST-06 *Including 02 PH-OH & **01** PH-HH) for the post of Junior Engineer (E&M) under post code 30/15, in DJB with closing date 26.11.2015. Tier-I written examination was conducted on 24/09/2017. Further, the result for Tier-I Exam was declared vide result Notice No. 426 dated 04/05/2018. Total 515 (UR-317, OBC-83, SC-130 & ST-28 including 02 PH) candidates were shortlisted for tier-II examination.
- 2. The tier-II written examination was conducted on 03.06.2018 wherein 468 candidates appeared in tier-II exam.
- 3. The marks obtained by 467 candidates who have appeared in written examination have been uploaded on Board's website. Further, vide Notice no. 700 dated 01.08.2018 read with addendum No. 735 dated 05/11/18, total 170 candidates were called for uploading the dossier. The e-dossier link was activated w.e.f. 03.08.2018 to 17.08.2018. Total 167 candidates have been uploaded the documents through e-dossier module in stipulated time.
- 4. On the basis of marks secured in written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of Junior Engineer (E&M) under post code 30/15 in DJB, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

- 7. The candidate having Roll No 16401391 is directed to submit upload his pending documents i.e. OBC(Delhi) Certificate in the edossier module in stipulated time failing which his candidature will be rejected without any further notice.
- 8. The e-dossier link shall be active from 02.02.2019 to 12.02.2019.
- 9. The selection of the above 89 candidates (UR-47*, OBC-23, SC-13 & ST-06 including 02-PH-OH) shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 10. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Delhi Jal Board(DJB) is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of



documents/certificates and essential qualification for the post before finally appointing the candidate.

- 11.User Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993 O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.
- 12. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 13. The above said result is subject to outcome of pending Court cases 3306/2017 (Sushil Kumar Verma V/s DJB), 2197/2018 (Amit V/s GNCT of Delhi) and 3069/2018 (Md Saifullah Ansari V/s DSSSB) in Ld. CAT.
