Attention is drawn to the Notice No. 867 dated 19/12/2019 vide which the normalized marks of candidates were declared who appeared for the Online Examination held on 20/09/2019, 24/09/2019, 30/09/2019, 01/10/2019, 03/10/2019 and 04/10/2019 and candidates were shortlisted for appearing in Skill Test, Notice No. 1043 dated 08/09/2020 vide which roll no. of skill test qualified candidates were declared and shortlisted candidates were informed to fill the e-dossier and upload all the requisite documents as per requirement of RR and as per requirement of their application form to the post of Grade-IV (DASS)/Jr. Assistant in Services Department under Post Code 02/17. Attention is also drawn to the Result Notice No. 1072 dated 12/10/2020 vide which results were declared for the Post of Grade-IV (DASS) in Services Department under Post Code 02/17.

2. Attention is also drawn to the Board's Order No F. 55(237)/EXAM/DSSSB/2021/4959 dated 07/06/2021 vide which the Candidate RAHUL MANN, having roll No. 12340203403 under post code 02/17, DOB: - 27-07-1996, S/o SATISH KUMAR MANN, 382, PRAHLAD PUR BANGER DELHI has been debarred from any examination conducted/ to be conducted by DSSSB for life time w.e.f. 20/09/2019. Further, candidature of Sh. RAHUL MANN will be deemed cancelled if he appeared in any examination conducted by the Board prior to above date.

3. That vide above-mentioned debarment order dated 07/06/2021 it has been found/conveyed to all that Sh. RAHUL MANN whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activities like Cheating, Impersonation, Forgery, Conspiracy, etc. during the above said post code exam:-

4. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/malpractices and further, that:

*'Any attempt to commit or abet, as the case may be, all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to rendering himself/herself liable to criminal prosecution, be liable:*

- a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/she might have appeared but the final result/selection has not been declared/made and or*
- b) To be debarred either permanently or for a specified period which may extend to 10 years by the Board from any examination held or selection made by them and or,*
- c) To take disciplinary action under appropriate rules if he/she is already in service under Government and or,*
- d) To take any other legal action.'*

5. Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post codes in online, offline and PET/Skill Test examination.

*"If any case of impersonation comes to notice then overall in-charge and observer shall lodge FIR against both persons, i.e., candidate who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/Commissions."*

6. Thus it is clear that the candidate had arranged to have another person taking examination in place of him. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i. Appearing in examination for another candidate or arranging to have another person take an examination for the candidate.
- ii. Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii. Helping or receiving help from other candidates/persons to impersonate.
- iv. Signing /getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v. Providing admit card and Aadhar Card (with change of photo) to another person to enable him to appear on behalf of the candidate.

7. Further, the candidate has also indulged in the act of **FORGERY** by altering the identity proof of candidate, admit card etc. and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

8. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

9. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the Candidate.

10. The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view of the above facts and circumstances, the candidature of the candidate **Sh. RAHUL MANN, S/o SATISH KUMAR MANN, R/o 382, PRAHLAD PUR BANGER DELHI**, having Date of Birth 27-07-1996, bearing roll no. 12340203403 of post code 02/17 is hereby cancelled and the provisional selection made vide Result Notice No. 1072 dated 12/10/2020 of candidate **Sh. RAHUL MANN, S/o SATISH KUMAR MANN, R/o 382, PRAHLAD PUR BANGER DELHI**, having Date of Birth 27-07-1996, bearing roll no. 12340203403 of Post Code 02/17 is hereby rescinded.
