Whereas the DSSSB vide its advertisement No.04/17 had advertised 542(UR), 453(OBC), 211(SC) 123(ST), PH/OH-20 & PH/VH-20 for the post of **Special Education Teacher, Post Code-87/17 in Directorate of Education**. The offline written examination of Tier-I held on 29/07/2018. The marks of all the candidates were declared vide notice dated 14/09/2018 in their OARS module on www.dsssonline.nic.in.

Whereas as per SOP, the scanning & evaluation of answer sheets of the candidates was required to be done through computer without any manual intervention.

Whereas as per instructions for candidates in Answer sheets given at the time of written examination, it has clearly been mentioned at Sl.No.6 of the Answer sheet that "The appropriate circle should be shaded for Roll No., Question Booklet No. and Preference of Post Codes applied for etc. This should be done carefully because only the shaded circles are scanned.

Whereas on scrutiny of the answer sheet, it revealed that the candidates listed below failed to correctly bubble the appropriate circles provided for Roll No. in their answer sheets:-
