1. The DSSSB vide its advertisement no. 04/2020 dated 04/01/2020 with closing date 23/02/2020 and subsequent corrigendum dated 14/01/2020 had advertised 08 vacancies (**UR-04, OBC-02, SC-01, ST-01**) for the Post of **PGT Physical Education-Male** under post code 85/20 in Directorate of Education.
2. The written examination (online mode in single shift) Tier-I (Technical) for recruitment in respect of this post was conducted on 29/06/2021.
3. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll Nos. in respect of the above mentioned post code have been found to be '**Not Eligible**' in terms of the advertisement no. 04/2020 dated 04/01/2020 and Recruitment Rules for the post of **PGT Physical Education-Male** under post code 85/20 in Directorate of Education, GNCTD. The candidature of these candidates, therefore, stands rejected:-

Despite two opportunities, the candidate failed to upload documents relates to essential educational qualification of the post code, advertised in Advt. No. 04/2020 dated 04/01/2020. Therefore, the candidature of the candidate stands rejected for the post code 85/20.

No. 04/2020 dated 04/01/2020, on closing date of application i.e. cut off date 23/02/2020. Further, as per clause 7 (viii) of Advertisement No. 04/2020 dated 04/01/2020, i.e. GENERAL INSTRUCTIONS FOR CANDIDATES, It is informed that " <i>the educational qualification, age experience and other eligibility conditions against the post shall be determined as on the closing date of online submission of application</i> ".

			Therefore, as the candidate was not possessed essential educational qualification on 23/02/2020, his candidature is being rejected in post code 85/20.
3	11150600104	ST	As per the MPE Degree (provisional) and Marks Sheets submitted in the e-dossier, the candidate was not having essential educational qualification mentioned in Advt. No. 04/2020 dated 04/01/2020, on closing date of application i.e. cut off date 23/02/2020. Further, as per clause 7 (viii) of Advertisement No. 04/2020 dated 04/01/2020, i.e. GENERAL INSTRUCTIONS FOR CANDIDATES, It is informed that <i>"the educational qualification, age experience and other eligibility conditions against the post shall be determined as on the closing date of online submission of application"</i>. Therefore, as the candidate was not possessed essential educational qualification on 23/02/2020, his candidature is being rejected in post code 85/20.
