In continuation of Rejection Notice No. 440 dated 22.05.2019, Rejection Notice No. 523 dated 01.10.2019 & Rejection Notice No. 640 dated 06.07.2020, on scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of TGT (Hindi) Male, Post Code-140/17 in Directorate of Education and the terms and conditions of the advertisement, the candidature of the candidates bearing roll nos. mentioned below is rejected for the reason mentioned against each roll no.:-

UR CATEGORY:-

Sl. No.	Roll No.	Reason
1	120114002157	The candidate has qualified CTET in relaxed standard under OBC category in 2016. However, he is OBC (outside) and considered as UR category candidate. He has also uploaded CTET certificate with 90 marks in 2019 which is after cutoff date. Hence, is not eligible for not having qualified CTET under UR ctgy. OBC certificate issued from Rajasthan.
2	111214000293	The candidate has qualified CTET in relaxed standard under OBC category. However, he is OBC (Outsider). Hence, his candidature cannot be considered under UR category for passing CTET with relaxed standard. Further he also cannot be considered under OBC ctgy. for being OBC (Outsider). OBC certificate issued from U.P.
3	110614000834	The candidate has qualified CTET in relaxed standard under OBC category. However, he is OBC (outside) and considered as UR category candidate. Hence, is not eligible for not having qualified CTET under UR ctgy. OBC certificate issued from Rajasthan.
4	120114001213	The candidate has qualified CTET in relaxed standard under OBC and applied under UR category. Hence, his candidature cannot be considered under UR category for passing CTET with relaxed standard.

ST Category:-

Sl. No.	Roll No.	Reason
1	110714000280	CTET after cutoff date. The candidate was given 1 st opportunity w.e.f. 24.02.2021 to 05.03.2021 & 2 nd and final opportunity w.e.f. 11.03.2021 to 15.03.2021 to upload the CTET certificate as on cutoff date but he failed to upload the same. Hence, he is not eligible for having CTET after cutoff date.
