REJECTION NOTICE NO. 8 7 MATRON (Only for Female) In Delhi Prison Department, Post Code 85/17

On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidate having roll number 1103850130 in respect of the above mentioned post code has been found to be 'Not Eligible' in terms of the advertisement no. 3/2017 and the Recruitment Rules for the post of Marton, Post Code 85/17 in Delhi Prison Department. The candidature of this candidate, therefore, stands rejected on following grounds:

2. The Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/malpractices and further, that:

'Any attempt to commit or abet, as the case may be, all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to rendering himself/herself liable to criminal prosecution, be liable:

- a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/she might have appeared but the final result/selection has not been declared/made and or
- b) To debarred either permanently or for a specified period which may extend to 10 years by the Board from any examination held or selection made by them and or,
- c) To take disciplinary action under appropriate rules if he/she is already in service under Government and or,
- d) To take any other legal action.'
- 3. While segregating the second page of Admit Cards of Shortlisted candidates / selected candidates it was discovered that:-
  - (i) the crossed signed Post Card Size Photograph which was affixed by the candidate herself, on 2<sup>nd</sup> page of Admit Card and submitted to the Board on the date of examination(s), i.e., on 19/12/2018 for PET having roll no. 2730020324 and on 29/03/2019 for Online Written Examination having roll no. 1103850130, are of two different person.
  - (ii) The copy of Aadhar Card uploaded by the candidate in her e-dossier link on OARS module of DSSSB and the Aadhar Card produced by the person on the date of written examination, i.e., on 29/03/2019, before examination functionaries are having the same Aadhar Card Number, i.e., 978770706256, but photographs on Aadhar Card is of two different people.

- 4. Thus, it is clear that the candidate PRIYA (DOB:- 08/10/1999) having roll no. 1103850130 had arranged to have another person taking examinations for herself, for this post code -85/17, on 29/03/2019 from 8:30 AM to 10:30 AM at Fringe Institute of Advanced Studies, 234, Budhpur, GT Karnal Road, Near Jain Mandir, Alipur Road, New Delhi-110036. Thus the candidate Priya and the impersonator have indulged in the following activities amounting to impersonation:
  - a) Appearing in examination for another candidate or arranging to have another person take an examination for the candidate.
  - b) Allowing/Making somebody else to write answers on candidate's behalf during examination.
  - c) Helping or receiving help from other candidates to impersonate.
  - d) Signing / getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
  - e) Proving admit card and Aadhar Card (with change of photo) to another person to enable her to appear on behalf of the candidate
- 5. Further, this candidate along with the impersonator have also indulged in the act of forgery by altering the identity proof of candidates, admit card etc and produced this documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.
- 6. Therefore, it is evident that the candidate PRIYA along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.
- 7. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the Candidate mentioned:-

- 8. Furthermore, attention is drawn to the following provisions at Para No. 13 and 14 of the "General Instructions for Candidates for the Post Code 85/17 and 63/15 in online made dated 26/03/2019.
- "13. The Board reserves the right to reject the candidature of any candidate at any stage of recruitment. Further, candidature of every candidate is purely, provisional, at every stage until he is offered appointment by the concerned Department to which the Post belongs, after due verification of documents and eligibility in respect of the post.

- 14. The candidature of the candidate in respect of the written examination is entirely provisional and subject to the outcome of any direction/decision/order/pronouncement of any Court of Law and mere issue of e-admit card or appearance for examination does not entitle him/her to any claim for the post."
- 9. The DSSSB also adheres to Zero tolerance Policy towards any misconduct by any candidate or any person. Therefore, in view of the above facts and circumstances, the candidature of the candidate PRIYA (DOB:- 08/10/1999) having roll no. 1103850130 for the post of Matron in Delhi Prison Department, under Post Code 85/17 is hereby cancelled, on finding her involved in the acts as mentioned above.
