The DSSSB vide its advertisement No. 04/19 dated 24.09.2019 had advertised total **706** [EWS-21, UR-190, OBC-115, SC-309, ST-71] vacancies for the post of **Fire Operator in Delhi Fire Service, Post Code-18/19** with closing date as 06/11/2019. Physical Endurance Test was held w.e.f. 11.01.2020 to 22.02.2020. Online written Examination was held on 20.04.2021 & 22.04.2021 & Skill Test (Driving) was held w.e.f. 31.05.2022 to 01.08.2022.

- 2. The result for the post of Fire Operator, Post Code-18/19 was declared vide main Result Notice No. 897 dated 09.02.2023 wherein two candidates **Sh. Naresh Kumar Meena**, Roll No. 4660044341 (PET), 111200500989 (Written Exam), 7030000710 (Skill Driving Test) under ST category & **Sh. Vikas Yadav**, Roll No. 4660004181 (PET), 112500500814 (Written Exam), 7030000888 (Skill Driving Test) under OBC category were provisionally nominated for the post code-18/19.
- 3. On scrutiny of biometric reports taken during CBT and Driving Skill Test for Post Code-18/19 (Fire Operator) in Delhi Fire Service by DSSSB, it has been found that Sh. Naresh Kumar Meena (Roll No. 7030000710) under ST category & Sh. Vikas Yadav (Roll No. 7030000888) under OBC category were found in indulging in unfair means, malpractices and criminal activity like cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code exam and therefore, the candidate Sh. Naresh Kumar Meena S/o Sh. Ram Khilari Meena having Date of Birth 06/09/1990 bearing Roll No. 4660044341 (PET), 111200500989 (Written Exam), 7030000710 (Skill Driving Test) has been debarred from any examination conducted / to be conducted by the DSSSB for life time w.e.f. 22.02.2020 vide Order No. F. 55(237)/Exam/DSSSB/ 2021/Part-III/661-71 dated 14.06.2023 & Sh. Vikas Yadav S/o Sh. Krishan Kumar having Date of Birth 05/10/1995 bearing Roll No. 4660004181 (PET), 112500500814 (Written Exam), 7030000888 (Skill Driving Test) has been debarred from any examination conducted / to be conducted by the DSSSB for life time w.e.f. 21.01.2020 vide Order No. F. 55(237)/Exam/DSSSB/2021/Part-III/671-80 dated 14.06.2023.
- 4. Now, therefore, in view of Debarment Orders dated 14.06.2023 of Examination Branch & Cancellation Orders dated 26.06.2023 issued by Delhi Fire Service, the candidature of **Sh. Naresh Kumar Meena** (Roll No. 7030000710) under ST category &

Sh. Vikas Yadav (Roll No. 7030000888) under OBC category is cancelled / rejected for the post of Fire Operator, Post Code-18/19 and their Roll Nos. 7030000710 & 7030000888 are rescinded from the Main Result Notice No. 897 dated 09.02.2023.
