This is in continuation of Result Notice vide Office Order No. 327 dt. 8.5.2014, the Board had declared this result as per qualifying marks mentioned in advertisement as 45% for UR category and 35% for Reserved category. The Board has, now, decided to declare the result on the basis of existing policy on qualifying marks as 40% for UR, 35% for OBC and 30% for SC/ST/PH category. Therefore, the qualifying marks for candidates of SC category comes down from 70 marks to 60 marks. The Board had considered the names of SC candidates for selection who obtained upto 60 marks and the following SC candidates were found 'NOT ELIGIBLE' due to various reason mentioned in remarks column :
