REJECTION NOTICE TEACHER (PRIMARY) POST CODE-70/09 MUNICIPAL CORPORATION OF DELHI

On the basis of written examination held on 02-02-2014 and eligibility regarding education qualification as per Advt./RRs, eligibility as on cut-off-date i.e. 15-01-2010 and age limit etc. as per Advt. No. 004/09 for the post of Teacher (Primary), Post code 70/09 & further verification of documents by the staff of MCD, the following candidates are declared as "Not Eligible" and their candidature for the post of Teacher (Primary), Post code 70/09 is hereby rejected due to various reasons which are shown against their names in remarks Column. Also, the candidature of those candidates who have obtained less than minimum qualifying marks in their respective categories is also hereby rejected. This is subject to outcome of Court cases/CAT cases pending in respect of this post code.

The result has been processed keeping in view of the eligibility conditions regarding educational qualifications/caste certificate/disability certificate etc. as on cut-off date i.e. <u>15-01-2010</u>. If any candidate has grievances regarding his educational qualifications etc., he/she may approach the user department, i.e. MCD, as the eligibility has been checked as per the RRs provided by the user department. The Hon'ble High Court of Delhi vide judgement dated 06/02/2013 in WP(C) 3397/2012 titled as DSSSB V/s. Preeti Balyan ordered that the cut off date would be 15-01-2010 for the post code 70/09. Therefore, in compliance of the judgement of Hon'ble High Court of Delhi, the candidature of those candidates, who had not completed their eligibility criteria as on 15-01-2010, have been rejected. While every care has been taken in preparing the results, the DSSSB reserves the right to rectify errors and omissions, if any.
