On the basis of written examination held on 31.08-2014 and eligibility regarding education qualification as per Advt./RRs, eligibility as on cut-off-date i.e. 27.02.2014 and age limit etc. as per Advt. No. 1/14 for the post of Fire Operator, Post code 71/14, the following candidates are declared as "Not Eligible" and their candidature for the post of Fire Operator, Post code 71/14 is hereby rejected due to various reasons which are shown against their names in remarks column. Also, the candidature of those candidates who have obtained less than minimum qualifying marks in their respective categories is also hereby rejected.

The Cut-off/qualifying marks for UR is 90/200, for OBC is 70/200, for SC/ST is 60/200.

The result has been processed keeping in view of the eligibility conditions regarding educational qualifications/caste certificate/disability certificate etc. as on cut-off date i.e. 27.02.2014.
