The DSSSB vide its advertisement No 03/2013 with closing date 18/10/2013, had advertised 289 vacancies (UR-147, OBC-78, SC-43, including PH/OH-05 & PH/HH-04) for the post of Junior Engineer in the pay scale of Rs 9300-34800 + Grade Pay Rs 4200/- (pre-revised) in the Department of MCD under Post code 69/2013. Board has conducted Tier-I written examination for recruitment to this post on 31.01.2015. On the basis of marks scored in Tier-I examination, the Board had shortlisted 84 candidates for appearing in Tier-II examination.

The Tier II examination was held on 30.04.2017. On the basis of the marks scored by the candidates in Tier-II examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of Junior Engineer subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application forms.

The following candidate is declared as **"Not Eligible"** and their candidature for the post of Junior Engineer (Civil), Post code 69/13 is hereby rejected due to various reasons which are shown against their names in remarks column. The result has been processed keeping in view of the eligibility conditions regarding educational qualifications/caste certificate/disability certificate etc. as on cut-off date i.e. 18.10.2013.
