The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of information/documents/caste certificate furnished in the application forms. Further, the recognition of the Universities/Board/Institution from which the degree/diploma/certificates has/have been submitted by the candidates should also be verified by the User Department, Directorate of Education, GNCT of Delhi.
