## ORDER

This order shall dispose of the representation/grievance dated 25.06.2021 filed by Ms. Renu (Roll No. 11171500031) candidate for the post of Assistant Teacher (Nursery), Post Code-16/19.

- 2. The candidate Ms. Renu (Roll No. 11171500031) applied for the post of Assistant Teacher (Nursery) under Post Code-16/19 under SC/PH/OH category and appeared in the computer based online examination on 19.11.2019 and scored 76.75 marks out of 200 marks. The Candidate was shortlisted for uploading of all the relevant documents in the e-dossier with regard to <a href="Educational/Professional Certificates/Degree and Mark sheets/CasteCertificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module w.e.f. 30.06.2020 to 14.07.2020 (15 days) vide Notice No. F. No. 236/Result/Asstt. Teacher(Nursery)/Int. Cell/DSSSB/2019-20/1636-44 dated 22/06/2020 on the Board's website i.e. <a href="https://www.dsssb.delhi.gov.in">www.dsssb.delhi.gov.in</a>.
- That on scrutiny of the documents uploaded in the e-dossier by Ms Renu (Roll No. 11171500031), it has been found that the candidate has uploaded marks sheet of B.Ed. whereas Two years diploma in Nursery Teacher Training or B.Ed. (Nursery) from a recognized Institute was required as per RRs. As the candidate has mentioned in OARS application form that she has done B.Ed. (Nursery) from CCS University, Meerut in October, 2017 with 70.28% marks, she was given 10 days first opportunity w.e.f. 11.06.2021 to 20.06.2020 to upload "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" vide notice dated 10.06.2021.
- 4. That even after giving 10 days 1<sup>st</sup> opportunity w.e.f. 25.11.2020 to 04.12.2020, it was found that Ms. Renu (Roll No. 11171500031) falled to upload the deficient / requisite documents in the e-dossier. She was given 05 days, 2<sup>nd</sup> and final opportunity w.e.f. 23.06.2021 to 27.06.2021 to upload (i) "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" & (ii) OBC (Delhi) certificate vide Notice No. F. No. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/ DSSSB/ 2019-20/1616-24 dated 22/06/2021. The candidate has again failed to upload the above requisite documents in the e-dossier even after giving two opportunities. Hence, the candidature of the

candidate Ms. Renu (Řoll No. 11171500031) has been rejected vide Rejection notice No. 806 dated 16.08.2021.

- 5. That the candidate Ms. Renu (Roll No. 11171500031) has submitted representations dated 25.06.2021 stating that "I have been directed to upload B.Ed. degree but my documents are not being uploaded on the website". It is pertinent to mention here that she was asked to upload B.Ed. (Nursery) or two years diploma in Nursery Teacher Training from a recognized Institution as her B.ed. certificate already uploaded was not applicable for the post code-16/19 as per RR. She again enclosed B.Ed. degree with her representation which is not required in e-dossier.
- 6. That the above referred representation dated 25.06.2021 of the candidate has been examined in details and it is clear that her grievance/complaint is totally baseless as the edossier link for uploading of documents for all the shortlisted candidates including Ms. Renu (Roll No. 11171500031) was opened w.e.f. 30.06.2020 to 14.07.2020 and she had uploaded marks sheet of B.Ed. which is not applicable for the post of Assistant Teacher Nursery. Thereafter, she was given two more opportunities. First opportunity was given w.e.f. 11.06..2021 to 20.06.2021 & Second and final opportunity was given w.e.f. 23.06.2021 to 27.06.2021 but the candidate failed to upload the two years Diploma in Nursery or B.Ed. (Nursery) and accordingly, her candidature was rejected.
  - 7. In view of the above, the representations dated 25.06.2021 in r/o of Renu (Roll No. 11171500031) has been considered and examined in details and dismissed as the reason for rejection of her candidature for the post of Assistant Teacher (Nursery), Post Code-16/19 is justified as she failed to upload the requisite documents as per RR which was asked by DSSSB.

8. This issues with the approval of Competent Authority, DSSSB.
