REJECTION NOTICE NO.:- 1316 GRADE-IV (DASS)/JR. ASSISTANT (POST CODE 02/17) In SERVICES DEPARTMENT, GNCT OF DELHI

- 1. The DSSSB vide its advertisement number 01/2017 with closing date 21/08/2017 and subsequent Addendum dated 01/09/2019 and corrigendum to addendum dated 15/11/2019 had advertised 842 vacancies (UR-400, OBC-170, SC-106, ST-166 including OH-09, HH-48, VH-23, EXSM-129 AND SP-24) for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17. Board Conducted Tier-I written examination for recruitment in respect of this post on 20/09/2019, 24/09/2019, 30/09/2019, 01/10/2019, 03/10/2019 and 04/10/2019. Board had declared marks of Tier I written examination of the Candidates of the Post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17 vide notice number 867 dated 19/12/2019.
- 2. Based on the performance in the One Tier Examination, 5404 candidates were shortlisted for appearing in Skill Test/Typing Test for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17 vide notice number 867 dated 19/12/2019. The Skill Test/Typewriting Test was conducted on 24/12/2019, 26/12/2019, 27/12/209, 28/12/2019, 29/12/2019, 30/12/2019, 03/01/2020, 04/01/2020 and on 16/02/2020 wherein out of 4437 candidates only 1893 candidates could qualify. The result of skill test was declared vide notice no. 1043 dated 08/09/2020.
- 3. As per RRs for the Post the candidate was to qualify the 35 w.p.m. in typewriting in English or 30 w.p.m. in typewriting in Hindi.
- 4. On the basis of written Examination Tier-I held from 20/09/2019, 24/09/2019, 30/09/2019, 01/10/2019, 03/10/2019 and 04/10/2019 and being qualified in Skill Test held on 24/12/2019, 26/12/2019, 27/12/209, 28/12/2019, 29/12/2019, 30/12/2019, 03/01/2020, 04/01/2020 and on 16/02/2020 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 01/2017 and RRs for the Post of Lower Division Clerk under Post Code 02/17 in Services Department, DSSSB vide Result Notice No. 1072 dated 12/10/2020, Result Notice No. 1097 dated 07/01/2021, Result Notice No. 1104 dated 04/02/2021, Result Notice No. 1193 dated 15/07/2021 and Result Notice No. 1204 dated 04/08/2021 and Supplementary Result Notice No. 1226 dated 02/09/2021 has provisionally selected 693 candidates (UR-276, OBC-119, SC-79, ST-135, EXSM-25, Sports-16,



OH-24, HH-01, VH-18) for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17.

- 5. The User Department, i.e., Services Department, GNCTD vide letter dated 19/08/2021, 03/09/2021, 27/09/2021, 11/10/2021, 13/10/2021, 22/10/2021 and 29/10/2021 has returned dossiers of 65 provisionally nominated candidates [UR-29, OBC-06, SC-03, ST-16, ExSM-05(UR), Sports-01(OBC), VH-03(UR), OH-02(UR)] on the grounds that selected candidates either did not accept the offer of appointment or did not respond within the specific period. The validity of the waitlist panel for the post code 02/17 was up to 11/10/2021 and candidature of all these 65 candidates were cancelled by the appointing authority prior to the expiry of the waitlist panel, hence, candidate from waitlist panel have been considered for selection against the vacant posts created due to candidature cancellation order(s)/returned dossiers.
- 6. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll No. in respect of the above mentioned post code has been found to be 'Not Eligible' in terms of the advertisement no. 03/2013 with closing date 18/10/2013 and Recruitment Rules for the post of Lower Division clerk under post code 51/13 in Municipal Corporations of Delhi. The candidature of the candidate is therefore, stands rejected:-

			Where as all candidates were informed vide clause 5 (ii) of the said advertisement that Candidates who wished to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificates (SC/ST/OBC/Non Creamy layer/PH/Educational/Experience, etc.) issued by the competent/notified authority(in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
			Whereas, proper opportunities provided to the candidate and the candidate has submitted in his edossier, the OBC (Delhi) certificate No. 90500000326186 and NCL Certificate dated 03/10/2019 showing issuance of said OBC (Delhi) Certificate on 28/09/2017, i.e. after the cutoff date



(closing date of online submission of application), i.e., 21/08/2017. Since the candidate was not having OBC (Delhi) Certificate on 21/08/2017 in accordance with clause 5 (ii) of advertisement no. 01/17 dated 18/07/2017, his claim for OBC (Delhi) category has not been entertained and his application has been
considered against Un-reserved (UR) category vacancies, if eligible otherwise.
