1. The DSSSB vide its result notice number 413 dated 18.7.2016 and its subsequent result notice number 463 dated 06.01.2017 and result notice number 531 dated 10.07.2017 has selected 75 candidates for the post of TGT (SSt) (F) in Directorate of Education under Post code 09/2010.

2. At the time of declaration of result the candidature of candidate having roll number 6013853 (Archana Solanki) having 76 marks in Part-II examination was kept pending against the OH vacancy for want of documents. There was only one post of OH category. Similarly, the candidature of applicant namely Meena Kumari was kept as waitlist candidate in OH category.

3. As the candidate having roll number 6013853 did not furnish her document, her candidature was cancelled vide result notice No. 531 dated 10.7.2017.

4. As per the instructions of the Services Department, the Board vide notification dated 13.06.2013 had notified that waitlist panel shall be valid upto 01 year of declaration of result. The waitlist panel for the post of TGT (SSt) under postcode 10/2010 was valid upto 17.07.2017. As the candidature of one candidate was cancelled on 10.07.2017, accordingly the candidature of waitlist candidate in OH category- Ms Meena Kumari is hereby processed.

5. On the basis of the merit list of Part-II examination held on 08.04.2012, 29.04.2012 and 12.05.2012 whose marks were declared on 16.05.2016 and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of TGT (SSt) Female Post code 10/2010:

The selection of the above 01 Candidate shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.

The User department shall also check the eligibility of the reservation benefit. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ document as furnished in the application form vis-à-vis from the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of document/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
