LDC IN MAIDS UNDER POST CODE 156/2014

- 1. The DSSSB vide its result notice number 576 dated 17.11.2017 has selected 04 candidates for the post of LDC in MAIDS under postcode 156/2014. For selecting the candidates against the unfilled vacancies, 36 candidates were additionally shortlisted vide result notice number CC I/615 dated 23.3.2018 to appear in skill test Phase-II.
- 2. The skill test of 27 candidates was conducted on 15.04.2018, the result of the skill test phase-II was declared vide result notice number 674 dated 14.6.2018. The nine candidates having roll numbers 10945309, 10953505, 10953464, 10946990, 10941914, 10953746, 10948926, 10954880 and 10946905 had already qualified the skill test conducted on 9.4.2017.
- 3. The One Tier examination dated 30.08.2015 and the skill test were conducted as a combined examination for the postcodes 49/2012, 153/14 and 156/14. The selection of the candidate has been made as per their preference of postcode and as per the merit, subject to availability of the vacancies.
- 4. On the basis of the marks scored by the candidates in One Tier examination held on 30.08.2015, and thereafter qualifying the typing skill test, and after preliminary scrutiny documents furnished in e-dossier, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of LDC in MAIDS under postcode 156/2014, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in his OARS and veracity and scrutiny by User Department in regard to remarks mentioned against the candidates.

8. The candidature of candidate having roll number 10946990 has been kept pending in UR category to obtain her documents through e-dossier, whose link could not be released so far.

- 9. The candidature of candidate having roll number 10948926 is now in zone of selection in postcode 156/14 and also in postcode 153/14, as such his candidature is kept pending in SC category for seeking the preference of postcode.
- 10. Candidature of **01** candidate having roll number 10921177 is rejected as she has not uploaded anything in his e-dossier.
- 11. The selection of the above **08** candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 12. Further, due to lowering of cut off marks for shortlisting the candidates to appear for skill test Phase-II in UR category to 122.75 marks, the selection of candidate having roll number 10937595 made earlier in OBC category vide result notice number 576 dated 17.11.17 is hereby shifted to UR category:

Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application form & e-dossier vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.
- 14. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
