**STENOGRAPHER GRADE III

UNDER POSTCODE 211/2014**

1. The DSSSB vide its advertisement No. 02/2014 with closing date 25.01.2015, had advertised 47 vacancies (42 UR, 03 OBC, 01 SC, 01 ST including 01 HH, 05 EXSM, 02 SP) for the post of Stenographer Grade III in Services Department under Post code 211/2014 which were further increased to 349 vacancies (173 UR, 100 OBC, 36 SC, 40 ST including 07 VH, 01 HH, 04 OH, 42 EXSM, 02 SP) vide addendum dated 07.06.2018. Board conducted One Tier written examination for selection to the post along with similar postcodes on 11.06.2017. Board had declared marks of One Tier examination of the candidates of the post of Stenographer Grade III in Services Department under Post code 211/2014 vide notice number 550 dated 06.10.2017.
2. Based on the performance in the one tier examination, 489 candidates were shortlisted for appearing in Shorthand and Typewriting Skill Test vide notice number 564 dated 25.10.2017. The skill test result for shorthand and typewriting was conducted w.e.f. 08.02.2018 to 11.02.2018, wherein 341 candidates have appeared. The result of skill test was declared vide notice number 693 dated 23.7.2018 and corrigendum dated 26.07.2018.
3. The Board has adopted the criteria for evaluation of the skill test on the pattern of SSC and considered upto 7% mistakes in shorthand skill test for UR category and upto 10 % mistakes in shorthand skill test for all reserved category candidates, as qualified with a speed of 80 w.p.m. As per RRs for the post the candidate was to qualify the 40 w.p.m. in typewriting in English or 35 w.p.m. in typewriting in Hindi, aswell.
4. After preliminary scrutiny of the candidature of candidates on the basis of the documents uploaded by the them in their e-dossier as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the

10. Candidature of 03 candidates having roll number **14307063, 14307778, 14309993** is rejected in UR category as their % of errors in Shorthand skill test is more than 7% and thus not qualified the shorthand skill test as per UR category norms. Further these candidates are not selected in OBC category as they do not belongs to OBC (Delhi).

11. Candidature of 01 candidate having roll number **14304695** is kept pending in UR category as the candidate has furnished the higher secondary certificate. Pending for seeking the clarification from the user department regarding admissibility of the said qualification to the post.

12. Candidature of 01 candidate having roll number **14314875** is kept pending in OBC category for want of OBC certificate.

13. Candidature of 01 candidate having Roll number **14312978** have furnished the OBC certificate for appointment to the posts reserved under Government of India, therefore her candidature is kept pending.

14. Candidature of candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate

18. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.

19. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the 12th qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

20. In respect of the unfilled vacancies the DSSSB has proposed to further shortlist the additional candidates for phase-II of skill test.

21. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

22. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
