MOTOR VEHICLE INSPECTOR (MALE) IN TRANSPORT DEPARTMENT UNDER POST CODE 21/2012 AND 42/2013

The Board had conducted the Tier I examination for post codes 21/2012 and 42/2013 on 28/12/2014 and the Tier II examination on 29/03/2015. Thereafter, the final result was declared vide Result Notice No. 330 dated 24.07.2015, Result Notice No. 341 dated 13.10.2015, corrigendum dated 16.10.2015 and 20.10.2015, and Result Notice No. 459 dated 14.12.2016 and had nominated 11 candidates (07 candidates under postcode 21/2012 and 04 candidates under post code 42/2013) for the post of Motor Vehicle Inspector (Male) in Transport Department in the pay scale of Rs. 9300-34800 having Grade Pay of 4200/- (Non- Gazetted-Non Ministerial).

The candidature of the following candidates was pending for primarily seeking the requisite clarification regarding admissibility of essential experience as per the RRs of the post. The Board vide its letter No F.1(258)CC-II/DSSSB/2015/180 dated 29.07.2015 and subsequent reminder dated 02.09.2015 had requested the User Department, Transport Department to assist the Board for declaring the pending candidatures. However, without providing any assistance, Transport Department vide their letter dated 07.09.2015 informed the Board to make selection as per the notified RRs for the post. Further, Board vide its letter dated 15.12.2016, again sought clarification regarding the admissibility of experience certificates of the candidates, whose cases were pending, but again the User Department has not provided the same so far.

The essential experience as mentioned in RRs for the post of Motor Vehicle Inspector is as under:

"working experience of at least five years in reputed automobile workshop which undertakes repairs of both light motor vehicles, heavy motor vehicles, heavy goods vehicles and heavy passenger vehicles fitted with petrol and diesel engine."

Accordingly, relying strictly upon the RRs including instruction regarding the essential experience certificate, the Board has made the preliminary scrutiny of the dossier of the candidates whose candidature was kept pending in Result No. 330 dated 24.07.2015 and 14.12.2016, and hereby **reject the candidature** of the following candidates for the post of Motor Vehicle Inspector (Male) in Transport Department under post code 21/2012 and 42/13 due to reasons mentioned against each.
