# SUPPLEMENTARY RESULT NOTICE NO:1516 ASSISTANT TEACHER (PRIMARY) UNDER POST CODE- 42/21 DIRECTORATE OF EDUCATION, GNCTD.

- 1. This is continuation of Result Notice No. 1489 Dated 02.11.2022.
- 2. DSSSB vide Result Notice No. 1489 dated 02.11.2022 provisionally nominated Total 434 candidates [EWS-38, UR-313 (Including UR-PH-OH-04, UR-PH-VH-04, UR-PH-HH-03 & UR-PH-MD-05), OBC-06 (Including OBC-PH-VH-01), SC-44 (Including SC-PH-HH-01) and ST-33)] and waiting panel Total 93 (PH-OH-01, PH-VH-01, PH-HH-01, PH-MD-01, EWS-08, UR-63, OBC-02, SC-09 & ST-07) for the Post of Assistant Teacher (Primary) under Post Code- 42/21 in Directorate of Education subject to their fulfilling all other conditions of eligibility and correctness of information furnished by the candidate in their online applicant form and e-dossier.
- 3. The User Department i.e. Directorate of Education, vide letter No. 962-964 dated 26.10.2023 has provided report on returned and cancelled dossiers. The User Department has informed that all the nominated and waitlisted candidates under above Category have been utilized and requested to provide additional eligible candidates from the reserve panel of above category under post code 42/21 as under. Total 57 (EWS-09, UR-28, PH-HH-02, PH-VH-02, PH-MD-01, ST-15).
- 4. The validity of the reserve panel of post code 42/21 was valid up to 01.11.2023 and the returned dossiers along with complete status report were received from Directorate of Education prior to expiry of waitlist panel, hence, as per Board's resolution dated 19th May, 2021 in supersession of earlier policy dated 13 June 2019 and in accordance with Services Department Circular No. F.16(3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021, out of the waiting/reserve panel comprising all the candidates above minimum qualifying marks in Written Examination, the following additional total 12 candidates are hereby provisionally nominated from reserve panel of EWS- 01, PH-HH-01, PH-VH-01, ST-08 & OBC-01 Categories under post code 42/21 purely on the basis of marks obtained by the candidates in the examination held on Online Exam conducted on 07,16,20,27, 29 & 30.03.2022, as per Board's resolution dated 14/07/2022 with a request to the User Department to utilize the same, in conformity with DOPT guidelines and instructions of Govt. of NCT, Delhi issued from time to time and also mentioned in the Result Notice No. 1489 dated 02.11.2022.

- 5. The provisionally nomination of above 12 candidates (nominated from reserve panel) of EWS- 01, PH-HH-01, PH-VH-01, ST-08 & OBC-01 has been processed purely on the basis of marks obtained by the candidates in the examination held on Online Exam conducted on 07,16,20,27, 29 &30.03.2022 and also claims made by the candidates in their online application forms of the post code 42/21 for the post of Assistant Teacher (Primary) in Directorate of Education. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, the Board has not undertaken scrutiny of documents uploaded in the edossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 02/21 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 42/21 as on cut-off date 24.06.2021 before issuance of offer of appointment to the post.
- **6.** The category wise marks scored by the last provisionally nominated candidate of reserve panel are is as under:

- 7. The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate.
- 8. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment per se against the vacancies notified for the recruitment. Nomination of above candidates from Reserve Panel is on the basis of numbers of dossiers returned by the User Department within validity panel in respective categories/Sub-categories. They can only get the offer of appointment only in the event any vacancies (category-wise) arising due to non-acceptance of the offer of

- appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
- **9.** User Department being cadre Controlling Appointment Authority shall utilize the reserve panel subject to availability of candidates in respective categories/Subcategories and purely on the basis of merit following the relevant circulars/OMs guidelines issued by the Government.
- 10.While operating the waiting panel/reserve panel list, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt. (Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/ 2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
- **11.**The user department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall rendered the excess appointment void and illegal *Ab initio*.
- **12.**While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- **13.**Wherever the Court has directed to not declare result without leave of the court such cases will be dealt separately, if falling in main result/proposed 20% waiting panel list. The user department shall decide such cases subject to outcome of court case(s).
- 14. Waiting panel has already been expired and was valid upto 01.11.2023.
- **15.** The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 16. This issues with the prior approval of the Chairman, DSSSB.
