The competent authority of the User Department shall arrange to verify the correctness of information/documents as furnished in the application form, after verification of the same from original documents/issuing authority. **Further, the User Department i.e. MCD will ensure the eligibility with regard to age relaxation to be allowed to candidate as per the service rendered as contractual teacher as on 29.10.2007 as per direction of Hon'ble Court.**

The selection/appointment of above mentioned candidate shall further be subject to outcome of any court cases filed by any of the candidates whose candidature has been cancelled. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.
