**POST GRADUATE TEACHER (POLITICAL SCIENCE) (MALE)
IN DIRECTORATE OF EDUCATION
UNDER POST CODE 149/2012**

The DSSSB vide Result Notices number 487 dated 17.03.2017, 493 dated 22.03.2017 and 551 dated 09.10.2017 had declared the result of 63 candidates for the post of *Post Graduate Teacher (Political Science) (Male)* in Directorate of Education under **Post code 149/2012**.

Candidatures of the candidate having Roll number -34003867, 34003999, 34004505, 34000092 in UR Category; 34000086 in are hereby cancelled as these candidates have not provided requisite documents inspite of final notice dated 17.04.2018.

The representation of candidate having roll number 34001759 (Mohd Murslin) has been examined and in view of the fact that he has applied manually for the post of PGT (Political Science) under postcode 149/12 having ID number 2206769, competent authority has accorded the approval for consideration of his candidature in postcode 149/12 under OBC category. The marks of candidate in combined Tier-II examination for postcode 149/12 and 175/14 were 131.75 marks. For creating the vacancy on considering the candidature of Mohd Murslin in postcode 149/12, the selection of last selected candidate in OBC category i.e. of Rajeev Giri (34004445) who has secured 120.75 marks is hereby rescinded.

One vacancy in postcode 149/12 was kept pending in view of pending court case in the matter of Tarun Kumar Vs DSSSB in Ld CAT having OA number 2248/2015. As per the Ld CAT interim order dated 01.02.2018 in OA number 2248/2015 in the matter of Tarun Kumar Vs DSSSB, the marks of the applicant namely Tarun Kumar having roll number 34001577 has already been declared vide notice number 623 dated 9.4.2018. In view of the same the result for this vacancy is hereby processed as per merit.

The dossier of Sh Dinesh Goyal (34004111) selected to the post of PGT (Political Science) under postcode 149/12 in UR category vide result notice number 487 dated 17.03.2017 has been returned after cancellation vide letter number. DE 2 (8)(10) E II/DR/PGT Pol.Sc/17/2431 dated 2.11.2017 on the ground that the candidate has not accepted the offer of appointment given to him. The dossier was returned within a period of the one year of declaration of result.

On receipt of the requisite documents and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Political Science) Male **Post code 149/2012** subject to consideration and satisfaction of the user department of the remarks mentioned against the candidate, if any:

The candidature of candidate having roll number 34001759 and 34000003 are kept pending in OBC category and VH category respectively for obtaining the requisite documents from the candidates in online mode.

The selection of the above 06 candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department and satisfaction of the user department of the remarks mentioned against the candidate, if any. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

Further, the above selection is further subject to outcome of cases titled Priyanka Vs GNCTD in OA No 1157/16, MA 2722/16; Dilshad & Ors Vs DSSSB in OA No 966/17; Manish Sejwal vs DSSSB in OA No 1945/2017 and Mukesh Kumar Vs GNCTD & Ors in OA No 1463/2017.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
